This home is run by a private organisation and is registered for the care and accommodation of up to three children and young people who have emotional and/or behavioural difficulties. The manager has been registered since December 2018 and is suitably qualified for the role.

Two compliance notices have been served to this home to address breaches in regulations. Areas of concern relate to the protection of children standard and the leadership and management standard. This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged good at the last full inspection. At the interim inspection, Ofsted judges that it has sustained effectiveness.

The home has been unsettled since the last full inspection, resulting in two children leaving the home in an unplanned way.

Some of the current children go missing from the home. For one child, significant concerns about their involvement in risky behaviour in the community have been raised by the staff. Managers and staff are determined to learn from this experience. As a result, staff have undertaken additional training to improve their skills and knowledge. This will help them to improve their understanding of how to keep children better protected.

The manager is committed to making sure children are increasingly safe and has made some improvements to the risk assessments. However, the location risk assessment for the home is not up to date. Additionally, the manager has not requested return home interviews each time children go missing from the home.

Recently, the atmosphere in the home has become much calmer. Damage to the home has been repaired and other areas have been redecorated and refurbished. The outside spaces of the home have been tidied and work is underway to improve the back garden. The addition of new furniture and a fireplace give the home a homely feel. As a result, children can feel increasingly safe and nurtured.

Staff have worked closely with the children to help them engage with schools that will fully meet their needs. Staff have continued to work with other agencies to ensure that suitable alternative education arrangements are in place. Maintaining routines and continuing to learn new skills helps children to successfully move into new schools. This improves the children's opportunities in later life.

Staff have a good understanding of the therapeutic needs of children. They work in collaboration with social workers and child and adolescent mental health services to ensure that children receive support to improve their emotional well-being. In addition, staff are creative in the way that they help children to communicate how they are feeling. Investing time in understanding how children feel helps staff to provide the best possible care.

Staff encourage children to follow their interests and take part in clubs and activities in the community such as swimming and girl guides. Enjoying these activities helps children to be fitter and healthier. Additionally, supporting children in this way helps them to develop friendships, confidence and important social skills that will increase their social networks.

Recommendations

■ The home should play a full part in promoting the best interests of the child, proactively advocating for the child to ensure that others play their role and deliver the high quality support that is needed. Such partnership working should always take place: before a child arrives; while the child lives in the home and where the child prepares to return home, move to another setting or leave care. Where a placement is made in an emergency, the registered person should quickly engage with relevant persons to provide the best immediate care. ('Guide to the children's homes regulations including the quality standards', page 11, paragraph 2.4)

In particular the manager should be proactive in requesting that return home interviews are offered when a child returns after being missing from the home.
