# The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged good at the last full inspection. At the interim inspection, Ofsted judges that it has improved effectiveness.

The manager has met two of the three requirements and all six of the recommendations that were made at the last inspection. The unmet requirement will be repeated.

The children continue to make good progress. They have trusting relationships with a consistent staff team that knows and understands them. The staff evidence children's progress in a way in that is meaningful to the child. The staff are proud of the children's individual progress and celebrate their achievements with them. Communication and gaining children's views have improved. The staff use a variety of methods to ensure that children's wishes and feelings are listened to and acted on.

Since the last inspection, two children have moved to alternative placements and one child has successfully returned to live with their family. The manager has developed the impact risk assessments, considering children's needs and compatibility. This means that placements are being matched effectively.

Two of the children attend full-time education. One child is on a reduced education timetable. The staff are working closely with the education provider to ensure that the child is getting the support that she needs.

Risk assessments are comprehensive and regularly reviewed and updated. Child-friendly placement plans guide the staff in how to work with children on a day-to-day basis and incorporate their long-term plans.

Staff receive regular good-quality supervision. The manager supports the staff to have one-to-one sessions to review working practices and any conflicts. A member of staff said that she found this supportive and feels that it has made the team stronger and communication more transparent.

The staff have ensured that there are communication aids around the home to support the children. Pictorial complaints forms help the children to understand how to make a complaint. The manager responds using Picture Exchange Communication Systems or Widgets so that the children understand the action taken and the outcome.

The manager has reviewed the location risk assessment, considering risks in the local area and how these can be reduced. The assessment is robust and guides the staff in keeping the children safe.

The home is decorated to a high standard. Children's bedrooms are individually personalised and reflect the children's personalities and tastes.



Safeguarding incidents are managed well. The manager reports concerns appropriately and takes advice from the designated officer. However, some notifications to Ofsted have been late. This prevents Ofsted from having a current view of how well the children are safeguarded.
