Information about this children's home

The home is registered to provide care for four young people up to the age of 18. The home offers care for young people who have social and/or emotional difficulties. The home is privately owned.

There is a new manager in post. The manager is not yet registered with Ofsted.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged good at the last full inspection. At the interim inspection, Ofsted judges that it has sustained effectiveness.

At the last inspection four requirements were raised. Three of these requirements have been addressed. The manager has kept the home's statement of purpose up to date. Staff have completed additional relevant training and there is improved management oversight of staff training. Staff also now benefit from regular supervision.

One member of staff has still not managed to achieve a level 3 diploma in residential childcare within the regulatory timescale.

The frequency of young people going missing from home has reduced. However, when young people return to the home, staff do not ensure that return home interviews by an independent person take place. This creates a missed opportunity to fully understand the risks that a young person may have faced when they were away from the home and to ensure that the right action is taken to safeguard the young person.

Most of the home is clean and tidy, however the garden area continues to require attention to make it an inviting space for young people. In addition, the staff sleepin rooms are unpleasant. One room contains an industrial washing machine and tumble dryer, and the bed has been replaced by a futon bed. The other staff sleep-in room was used for storage, which limited access to the bed. One young person told the inspector that 'staff sometimes sleep in the living room as it's nicer than the staff bedrooms.' This does not create a homely environment for young people.

Since the fourth young person arrived at the home there have been times when the home has been unable to provide sufficient staffing. To date this has not placed young people at risk as staff know young people well and young people are settled in placement.

The staff roster does not accurately record the hours that staff have worked at the home. Some, but not all, of this information is recorded in the daily log book.

Managers and staff would benefit from additional training in taking emergency placements so that they are equipped to meet the needs of young people admitted to the home quickly.

All four young people attend schools or college and are making progress. Young people are meaningfully occupied at home, and staff support engagement in activities. Young people appear to have positive relationships with one another and with the staff team.

The registered person must— maintain in the home the records in Schedule 4; ensure that the records are kept up to date; and retain the records for at least 15 years from the date of the last entry. (Regulation 37 (1)(2)(a)(b)(c))	
This is in relation to maintaining a copy of the staff duty roster of persons working at the home, and a record of the actual rosters worked. (Schedule 4(3))	

Recommendations

■ For children's homes to be nurturing and supportive environments that meet the needs of their children, they will, in most cases, be homely, domestic



environments. ('Guide to the children's homes regulations including the quality standards', page 15, paragraph 3.9)

This is with specific reference to ensuring that the garden is an inviting space for children and improvements are made to the staff sleep-in rooms.

- When a child returns to the home after being missing from care or away from the home without permission, the responsible local authority must provide an opportunity for the child to have an independent return home interview. Homes should take account of information provided by such interviews when assessing risks and putting arrangements in place to protect each child. ('Guide to the children's homes regulations including the quality standards', page 45, paragraph 9.30)
- Homes set up for emergency placements as indicated and detailed in their Statement of Purpose will require sufficient staff trained and skilled in the admission and care of children, where their full background may not be known. ('Guide to the children's homes regulations including the quality standards', page 57, paragraph 11.6)
