Monitoring visit Inspected under the social care common inspection framework

Information about this children's home

This home is operated by a private provider and is registered to provide care and accommodation for three children who have social and/or emotional difficulties.

There a new manager in post who has submitted her application for registration to Ofsted.

Inspection date: 26 March 2020

This monitoring visit

This home was judged inadequate at a full inspection on 29 and 30 January 2020 when eight regulatory breaches were identified. Ofsted imposed a condition that the provider must inform Ofsted three months prior to admitting any child to the home following this inspection.

The registered manager has left the home and an interim manager is in post. The interim manager has submitted her application to Ofsted for registration. This monitoring visit was carried out remotely due to the Covid-19 pandemic and government restrictions on travel. It was completed via remote access to the home's records system and on the telephone. The inspector spoke with three members of staff, the interim manager and the responsible individual. There are no children living in the home. The responsible individual and interim manager have made good progress in addressing the shortfalls identified at the full inspection. Two requirements have been met and significant steps taken to address the others. As such, six requirements are repeated until these can be effectively assessed when children are living in the home.

The interim manager and responsible individual have put in place a new electronic records system in the home. The inspector was able to view mock risk assessments for children. These assessments were comprehensive, clear and provide guidance to staff about how to support children to reduce their risks. The interim manager has put in place a clearer and more comprehensive assessment for children whom she is



assessing for compatibility to the home. The new systems and processes help managers to make well-thought-out decisions about children's suitability for the home and give guidance to staff to inform their practice.

The interim manager and responsible individual have redesigned the manager's monitoring systems. This will enable managers to have a clearer oversight of children's information and records completed by staff. The interim manager has also completed a quality of care review in relation to the six months leading up to the last inspection. As a result, she has a clear idea of shortfalls and is addressing these. Monitoring systems are now in place to provide a way for managers to identify shortfalls.

Managers and leaders have undertaken recruitment of experienced staff to the home. There is currently sufficient staff for the home to admit one child and recruitment is ongoing.

The interim manager and responsible individual have ensured that electronic forms to record incidents, including physical intervention and other behaviours, help staff to meet recording standards. Staff have completed mock records so that the interim manager can be assured of their understanding and competence.

It is Ofsted's opinion that the home is now ready for children to move in and the three-month condition is lifted.

The registered person must maintain records ("case records") for each child which—	07/05/2020
include the information and documents listed in Schedule 3 in relation to each child;	
are kept up to date; and	
are signed and dated by the author of each entry. (Regulation 36 (1)(a)(b)(c))

Ofsted is aware of the challenges that Covid-19 is currently posing to those we inspect.
