The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged good at the last full inspection. At the interim inspection, Ofsted judges that it has sustained effectiveness.

Daily records evidence that children are benefiting from good routines and education attendance has improved.

There have been very few safeguarding incidents since the previous inspection. Children's needs are well understood and appropriately responded to by staff.

All of the requirements made at the previous inspection are met.

Risk assessments and positive behaviour support plans are comprehensive. They include helpful advice for staff to support effective communication and interventions to de-escalate concerning behaviours. Plans are reviewed and updated following any new information or incident.

Records generally capture information that is purposeful and child-centred. Placement plans include useful information about children's education arrangements and daily timetables so that staff can support attendance and progress. There is management oversight of records and plans.

One child has had his education, health and care plan reviewed but some of the information within the plan is out of date and does not support the home to promote development and education progress. During the inspection, the manager contacted the relevant professionals to address this.

Staff are receiving regular individual supervision in line with the home's policies. They also receive group supervision. Both forms of supervision demonstrate the use of reflective practice to support staff development.

The independent visitor's reports have been received by Ofsted in a timely way. Managers respond to recommendations made by the visitor.

There is evidence of effective multidisciplinary working and positive feedback from professionals. One reported, 'The team is very receptive to learning and development and the managers are eager to collaborate to inform practice.'

Managers are aware of the areas that require further development. There has been some delay in progressing children's care plans. The manager has ensured that the relevant planning meetings are now in place to progress care plans.
