A local authority operates and runs this home. It provides care and accommodation for up to four children and young people with emotional and/or behavioural needs. The manager has been in post since October 2019 and is in the process of making an application to the regulator.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has declined in effectiveness.

The home has been without a registered manager since 2018. The current manager is appropriately qualified and experienced for the position held. He has been in post since October 2019. He is in the process of making an application to register as a home's manager for this setting. He is supported in his role by his senior managers to help drive improvements forward.

Children's and young people's experiences are variable. Educational attendance and attainments are mixed. The provider has plans to reintegrate those children and young people into educational settings where there have been significant periods of absence. This will support the progress for children and young people, helping them to learn, enjoy and achieve.

Children and young people continue to enjoy spending time with staff, engaging with a variety of social and recreational activities. This improves relationships, helping children and young people to share thoughts and feelings with the adults who help look after them.

Risk assessments and risk management processes are poor. Risk assessments lack detail on how children's and young people's known risks are managed and how to mitigate the risk of harm. This means that staff do not know the full extent of the children's and young people's known risk-taking behaviours, and there is no clear guidance for staff to follow. Furthermore, this prevents the staff from providing appropriate support to children and young people to help them to learn how to keep themselves safe in and outside the home. This places children and young people at increased risk of harm because of their level of vulnerability.

Poorly managed responses to allegations made by children and young people mean that they cannot be confident that they will be helped and protected by those adults who help look after them. There is no system in place to feed back the experiences of children and young people, including allegations made. Nor is there an effective monitoring and review system in place to make continuous improvements to the quality of care provided to children and young people. This has delayed safeguarding arrangements for some children and young people. Additionally, this has not provided children and young people with reassuring messages that their views have been listened to and acted on.

The manager has not followed safeguarding and regulation processes that involve notifying Ofsted and the designated officer. This lack of transparency prevents the regulator and safeguarding agencies from providing independent oversight as well as any scrutiny of care arrangements that aim to promote the safety and welfare of



children and young people. Furthermore, this prevents good oversight by the manager to identify trends and patterns of behaviour that help to better protect children and young people.

Staff have not received all relevant training that is necessary to meet the needs of the children and young people in the home. A previous requirement to skill up staff through contextual safeguarding training has not been sufficiently addressed. Additionally, staff would benefit from training relating to awareness of self-harmful behaviours. A poorly skilled staff team means that they are unlikely to recognise and respond to risks and concerns effectively. This means that children and young people receive inconsistent care that hinders progress and does not support safer care arrangements.

The manager has introduced his own monitoring systems. They have not been effective at identifying shortfalls raised at this inspection. There are inconsistencies in recording of information. Hand-written records are not always legible, which makes it difficult for children and young people to see how they will be offered care and support. Furthermore, not all records are signed and dated by the author, which does not show accountability.
