Summary of key findings for parents

This provision meets requirements

- The childminder is aware that the procedures to follow, in order to safeguard children. She understands the importance of monitoring children's attendance and keeping up to date with new legislation.
- The childminder knows how to assess children's learning. She knows how assessment information can be used to plan and provide challenging learning activities that help children to make good progress.
- The childminder understands the importance of teaching children good hygiene routines, healthy lifestyles and in setting clear boundaries to help guide their behaviour.
- The childminder knows how to evaluate her practice and will seek the views of parents, other professionals and children to help identify areas for improvement.
- The childminder acknowledges the importance of building good relationships with parents and carers, including the need to share information about children's care and learning and development.
- The childminder has extended her knowledge and skills, for example, through completing training and sharing information with other professionals.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- Discussions were held with the childminder about practice to establish her understanding of the statutory requirements.
- The inspector viewed relevant documentation, including first-aid training and public liability insurance certificates.
- The inspector viewed the areas of the home that will be used by children.
- Discussions were held with the childminder, including how she assesses children and provide suitable learning activities and experiences for them.
