Information about this children's home

This home is one of a group of homes operated by the same organisation. The statement of purpose indicates that the home provides accommodation for up to three children, offering a period of stability to reflect on their difficulties and make plans for their futures.

The registered manager has been in post since June 2018.

This monitoring visit

This monitoring visit was conducted remotely due to COVID-19 (coronavirus). The inspector considered a sample of documents provided by email, and conducted telephone interviews with staff and video calls with children.

This children's home was judged as declined in effectiveness on 18 February 2020. Five requirements were raised, and two compliance notices issued in relation to shortfalls in regulations 12 and 13.

This inspection examined progress made at the home against the compliance notices. All areas of the compliance notices are now met.

The registered manager has stopped working in the home and plans to cancel their registration. The home is currently being managed by a registered manager from a nearby home while a permanent manager replacement is recruited.

Staff now complete timely risk assessments which include essential information about children. Staff and clinicians also complete support plans which are in line with the organisation's underpinning model of care. These two documents give clear guidance to staff to help them understand children, respond to their needs and

reduce risks for them. Children are safer in the home because of the guidance staff are now using.

The interim manager has clear oversight of incidents in the home. She ensures that there are reflective discussions with staff after incidents, which they learn from. Where action is needed, she ensures that this is followed through. By taking an active role in understanding incidents, the manager can ensure that staff practice develops, and a culture of curiosity is evolving. This will help staff to reflect on the reasons why they may see different behaviours in children and respond to meet their needs.

Staff have worked with children to help them understand positive relationships, but there have been some serious physical incidents between children since the last inspection. In response, staff are now confidently intervening to stop things from escalating and incidents are happening less often. As a result, children are beginning to be better helped to regulate their behaviour.

The interim manager and the responsible individual now have a good understanding of the home's strengths and weaknesses and have begun to address shortfalls effectively. For example, there is now a clear action plan to respond to concerns noted by the independent visitor. The interim manager's oversight has meant she can help staff to build their skills and understanding of their roles in the home.

The manager has made the staff rota clearer, but this does not always include full details for agency staff who are working with children or the manager in charge of the home.

Physical intervention in the home has become more effective. Staff intervene more quickly to prevent children from becoming distressed. This has meant that incidents are shorter and less intense. However, not all agency staff are trained to use the restraint method used by the home and so it is not clear how they can support effectively those staff who are trained.

Relationships with professional stakeholders are inconsistent. Some placing authorities have noted concerns regarding the quality of care children receive and the limited progress that children make. There is also a concern about communication with all levels of the home, internally and externally. Managers are working to address these shortfalls.
