## This monitoring visit

On 24 March 2020, a monitoring visit took place following concerns about safeguarding practice, raised by a notification. A compliance notice was issued.

The purpose of this monitoring visit was to inspect and review the compliance notice.

The provider has met the steps set out by Ofsted to meet the requirements of the compliance notice. Leadership and management outcomes are improved.

The provider appointed an interim manager to lead the home until the permanent manager could take up their post. The provider notified Ofsted about this appointment, as required. The interim manager identified improvements in several key areas of practice. Changes were made that resulted in safer care for children and young people.

The provider understands that the recent changes must be sustained. The provider has committed to making further improvements to the service. It is too early to judge the effectiveness of these changes for children and young people.
