Monitoring visit

Inspected under the social care common inspection framework

Information about this residential family centre

This residential family centre is run by a privately owned company which specialises in providing independent parenting assessments and support. The centre provides care and support for up to five families.

The centre does not currently have a registered manager. The previous registered manager recently resigned from her post. The centre has no families undergoing assessment and the provider is not currently accepting referrals for placements.

This monitoring visit

Ofsted conducted two previous monitoring visits of the centre, in October 2019 and January 2020.

The January monitoring visit resulted in Ofsted issuing the provider with one compliance notice and one requirement. The compliance notice was in relation to the provider failing to vet staff appropriately. The one requirement was raised to address weaknesses in the staff's management of medication.

As a result of the current COVID-19 crisis, no further visit has been made to the setting. This report was compiled following a review of correspondence received from the provider.

The provider has met the requirements of the compliance notice.

The provider submitted an action plan which outlined what action had been taken to resolve the identified weaknesses. The plan highlighted that all previously missing staff-vetting information had now been obtained. This included copies of the staff's identification and a written reference for a senior staff member. The action plan

stated that no further staff appointments have been made, and that existing staff have been provided with regular supervision.

The home has also met the one requirement made at the previous visit. The provider forwarded an action plan to resolve safety-related shortfalls that had been identified in relation to the staff's safe administration of medication. Staff have since received additional medication training and revised medication-recording tools have been introduced.

In conclusion, Ofsted is satisfied that the requirements of the compliance notice have been met. In addition, appropriate action has been taken to resolve previous concerns regarding the staff's management of medication.

The purpose of this visit was to monitor the action taken and the progress made by the residential family centre since its last Ofsted inspection.

This inspection was carried out under the Care Standards Act 2000.
