Information about this children's home

A local authority operates and runs this home. It provides care and accommodation for up to four children and young people who have emotional and/or behavioural needs. The manager was registered in May 2020.

This monitoring visit

Ofsted is aware of the challenges that COVID-19 (coronavirus) is currently posing to those we regulate. During this visit, the inspector took into consideration the impact of any measures being taken to slow the spread of COVID-19 by the home. The visit went ahead remotely.

This children's home was judged declined in effectiveness at an interim inspection on 12 March 2020. Three compliance notices were issued under regulation 12, 13 and 40. Following this monitoring visit, Ofsted considers that the conditions under the compliance notices have been met.

The manager has reviewed risk assessments and risk management processes. Risk assessments identify known risks with details of how to mitigate risk of harm. Staff have received refresher training regarding policies and procedures linked to safeguarding processes. This includes training around the relevant agencies to be notified of safeguarding concerns including the local area designated officer and Ofsted. This means that children and young people are better protected, as staff are familiar with relevant protocols that aim to keep children and young people safe.

The manager has sourced training around contextual safeguarding, awareness of self-harmful behaviour, as well as other training specific to meet the individual needs

of the children and young people in their care. This means that children and young people receive support from a staff team that has skills and knowledge to recognise risk of harm and respond accordingly. The effectiveness of this will be considered at the home's next inspection.

Consultation with children and young people has improved since the interim inspection. Records detail the direct work that has been undertaken with children and young people, their expressed views and how staff will respond. This provides reassuring messages to children and young people, offering a consistent approach to how they will be cared for.

The manager has reviewed his monitoring systems and there is a greater focus on mapping progress and achievements for children and young people. This is in its early stages of being implemented and the effectiveness is not yet known. This will be considered at the home's next inspection.
