## Information about this children's home

Ofsted is aware of the challenges that COVID-19 (coronavirus) is currently posing to those we regulate. During this visit, the inspector took into consideration the impact of any measures being taken to slow the spread of COVID-19 by the home. This has included the effect these have had on staffing arrangements and the current attendance of the children and young people.

The home is run by a private organisation and is registered to provide care and accommodation for up to three children or young people who have emotional and/or behavioural difficulties.

The manager has been registered with Ofsted since 2018 and is suitably qualified.

### This monitoring visit

This monitoring visit was undertaken to address concerns raised through the independent visitor's report. The visitor noted that risk assessments relating to matching considerations and bullying between the children did not safeguard and promote their well-being. The inspector subsequently found no breaches in regulation.

Admissions to the home are well planned, and risk assessments are thorough. All known areas of risk are evaluated and sufficiently assessed. This helps to keep the children and young people increasingly safe.

The manager accepts that there have been issues with bullying. As a result, she introduced positive strategies to educate and promote safety with the children and young people. For example, an anti-bullying workshop, a proactive risk assessment



and regular key-worker sessions took place. A multi-agency approach supported the reduction and management of incidents with additional support directly from the police when required. This helped the children and young people understand the legal aspects of keeping themselves increasingly safe.

Some of the children and young people have successfully moved on in accordance with their care plans. As a result, the remaining children and young people are now experiencing a more settled home environment.
