Information about this children's home

This home was registered with Ofsted on 26 March 2020 to provide care to one young person who is assessed as requiring support with their emotional and/or behavioural needs. The home is operated by private provider who operates other homes in the South West and nationally. The home is situated near a city and is close to local amenities.

This monitoring visit

During the current COVID-19 (coronavirus) crisis, Ofsted is not carrying out routine inspections of social care provisions. When Ofsted has judged a service to be high risk, we need to determine what activity is needed to mitigate the risk.

Due to off-site inspection activity raising concerns, an urgent on-site inspection was carried out. Due to the COVID-19 pandemic, no grading was given.

The first young person to live in this newly registered home moved in during May, when COVID-19 lockdown restrictions were still in force. The young person has not made progress during this time. His emotional well-being has deteriorated, the risk of self-harm and harm to others has increased and he is now involved in the criminal justice system.

Most of the staff team members, although well-intended, do not have sufficient experience or qualification to meet the complex needs of this young person. The registered manager's actions have not compensated for these shortfalls, and his leadership lacks positive role modelling, despite support from senior managers for him and the staff team. Supervision and other records lack necessary information and do not assist in providing clear guidance to staff.

The difficulties that the staff have in providing well-balanced routines and boundaries for the young person's physical and emotional well-being have become visible to the local community. The inability of the staff to meet the young person's needs has meant that concerns have spilt into the garden and street, outside of the home. This has led to friends being entertained on the door step and serious incidents occurring, one involving a knife. Residents and others have become anxious and/or angry, leading to a catalogue of complaints being made and the situation becoming untenable. The young person is now fearful each time he leaves the house, which has exasperated his mental health issues and led to the local police being concerned about his well-being.

Despite staff's efforts to build a relationship and initiate creative ways to distract the young person, such as wild camping, the care given has been eventually reduced to reactive responses and providing accommodation and food of limited nutritional value. Latterly, the young person has spent much of his time unsupervised by staff in his friend's home. This is a situation that staff have had limited control over but have become increasingly and inappropriately reliant on.

Throughout the monitoring visit, the senior manager was open about the difficulties and shortfalls in the home. The provider sought to engage with the local community and communicated regularly and openly with Ofsted to identify strategies to attempt to alleviate the difficulties. Although the responsible local authority asked for the young person to continue living in the home, the home's senior manager had to insist that he move. The senior manager was of the opinion that the young person could not be kept safe, both in and out of the home. Senior leaders of the organisation said that they will not admit another young person until they have taken time to make improvements and address the local community's concerns.

Statutory requirements have been set to address the regulatory beaches found at this inspection. Ofsted will continue to monitor this home.
