### Information about this children's home

This children's home is owned and managed by a sole provider. It provides care and accommodation for up to three children whose plan is for them to live in medium- to long-term residential care.

## This monitoring visit

This monitoring visit was carried out to assess the progress made towards meeting a compliance notice under Regulation 12 and a requirement under Regulation 13. The compliance notice and the requirement were set to address shortfalls found at the last monitoring inspection. The inspector found that while the compliance notice and the requirement had been met by the provider, the progress made was very recent and consequently the impact of the changes could not be fully assessed at this inspection. Since the last inspection, the registered manager has left and there is a newly appointed acting manager.

The acting manager has taken steps to ensure children's risk assessments have been updated and they now contain all the known risks to children. The risk assessments indicate the strategies and actions that staff should use to reduce the risk to children. Additional and refresher training and support for staff are helping them to better understand their responsibilities to keep children safe. Work is ongoing to improve staff practice.

Children are learning how to keep themselves safe. Some children are completing work through specialist services, which is helping them to manage their emotions. Other children are completing work around how to stay safe online. This aspect of progress is very new and therefore could not be fully evaluated at this inspection.

Children's needs are not well matched. There has been lots of risk taking and disruptive behaviours at the home. A range of new strategies are helping children to

manage their relationships positively. Staff are starting to implement firmer boundaries and routines for the children. These changes are new, and staff's efforts have not yet been embedded. At times, children's behaviour continues to impact negatively on each other, particularly at night. Notice to end one child's placement has been issued by the provider.

The acting manager takes action to address concerns around children's welfare. However, this is not always recorded to provide transparency and clarity. This lack of recording does not demonstrate the learning taken from incidents and it does not reduce the risk of concerns reoccurring.

The revised staff supervision structure ensures that staff are aware of their responsibilities. The supervisions currently lack reflection around children's care needs and the individual work staff undertake with the children. The lack of reflection is a missed learning opportunity for improving children's care.

The acting manager's monitoring systems are improving. She is developing oversight of all areas of care practice and ensuring that staff are fulfilling their duties.
