Inspected under the social care common inspection framework

Information about this children's home

This children's home provides care for up to four young people. The home specialises in caring for girls who have been subject to child sexual exploitation. A private company owns and operates this home.

The current manager has resigned and is working her notice. A new manager has been appointed.

This monitoring visit

This children's home was judged good at the full inspection on 18 to 19 November 2019. The effectiveness of leaders and managers was judged as requires improvement.

On 23 July 2020, Ofsted completed a monitoring inspection of the home in response to safeguarding concerns and incidents that occurred at the home.

The inspector identified a number of concerns at this inspection.

There have been a number of serious incidents where young people have placed themselves at risk. The manager has notified Ofsted of some, but not all, concerns. This leaves the regulator without a clear oversight of the home.

The manager's response to incidents is poor. Not all serious concerns have been recorded as such and some have not been investigated sufficiently. This means that the manager can not be assured that appropriate action was taken to safeguard young people.

Documentation is poor. For example, incidents are not clearly reported and contain little information. In addition, staff do not always receive a debrief following a serious incident. This prevents staff from reflecting on their practice and considering what could have been done differently.

Staff purchase and provide young people with smoking vapes and liquids that contain high levels of nicotine. This inappropriate practice is not risk assessed and is without the consent of social workers or parents. In addition, not all risk assessments are updated following incidents. This leaves staff without the full information to inform their practice and reduce risks.

Managers have failed to ensure that staff complete key training in areas such as child exploitation, understanding self-harm, COVID-19 (coronavirus), how to change behaviour, social development and regulations and compliance training. This means that staff lack the knowledge to meet the needs of the young people placed in their care.

Managers have not ensured that young people are offered an independent return interview after periods of missing from home. This oversight means that young people do not have the opportunity to reflect on why they have placed themselves at risk.

The registered manager has resigned and is working her notice from home due to an injury sustained at work. The responsible individual has day-to-day responsibility for the home while they wait for the new manager to commence in post.

Following this inspection, one compliance notice was issued under Regulation 12. In addition, three new requirements were raised. Requirements raised at the full inspection in November 2019, will be reviewed at a future inspection.

Recommendations

- Children should be provided with appropriate furniture, such as a lockable cabinet or drawers to securely store personal items, including any personal information. Children should have separate bedrooms and should not share a bedroom with an adult. It may be appropriate for siblings of the same sex to share. Children should be given a choice about how their personal space is decorated in accordance with regulation 7(2)(a)(i). ('Guide to the children's homes regulations including the quality standards', page 16, paragraph 3.19)
- All managers working in a children's home must have the qualification in regulation 28(2) within the relevant timescales listed in regulation 28(3). All staff in a care role, including external agency or bank staff, must have the qualification in regulation 32(4) within the relevant timescale listed in regulation 32(5). The registered person may extend the time period if the member of staff has not worked in the role for a prolonged period, such as sick leave or maternity leave,



or if it is not reasonable to expect the member of staff to complete in this timescale due to the nature of the hours they work. ('Guide to the children's homes regulations including the quality standards', page 53, paragraph 10.12)

- The registered person is responsible for maintaining good employment practice. They must ensure that recruitment safeguards children and minimises potential risks to them. ('Guide to the children's homes regulations including the quality standards', page 61, paragraph 13.1)
- When a child returns to the home after being missing from care or away from the home without permission, the responsible local authority must provide an opportunity for the child to have an independent return home interview. Homes should take account of information provided by such interviews when assessing risks and putting arrangements in place to protect each child. ('Guide to the children's homes regulations including the quality standards', page 45, paragraph 9.30)

The purpose of this visit was to monitor the action taken and the progress made by the children's home since its last Ofsted inspection.

This inspection was carried out under the Care Standards Act 2000.

Ofsted is aware of the challenges that COVID-19 is currently posing to those we inspect. During this visit, the inspectors took into consideration the impact of any measures being taken to slow the spread of COVID-19 by the home. This has included the effect these have had on staffing arrangements.
