## Main inspection findings

Part 1. Quality of education provided

All paragraphs

- Leaders have planned a curriculum which will combine academic learning and therapeutic services. The curriculum policy sets out the five core principles of the school and supports leaders' ambitions for pupils.
- The curriculum is suitably broad and based on the national curriculum. Pupils will be assessed on entry and placed on a 'flight path' appropriate to their age and ability. Leaders have planned a robust assessment system, using 'I can' statements to assess pupils' understanding and set targets.
- The development of literacy and numeracy skills is mapped out across the curriculum. Curriculum plans include the teaching of phonics and early reading skills. Older pupils will have ample opportunities to obtain both academic and vocational qualifications.
- The development of pupils' social, emotional and mental health is an integral part of the curriculum. Each pupil will have an education, health and care (EHC) plan and the school will specialise in catering for pupils with autism spectrum disorder. Leaders aim to provide a bespoke curriculum based on pupils' individual needs.
- Careers guidance will be delivered through the 'Personal Development' programme. Secondary-aged pupils will complete qualifications in employability and attend work experience.
- Pupils will have access to a wide range of extra-curricular activities. Physical education (PE) lessons will be delivered weekly by a qualified sports teacher. A variety of educational trips and visits have also been planned.
- Leaders have detailed plans to promote pupils' personal, social, health and economic (PSHE) education effectively. These plans show that equalities and fundamental British values will be actively promoted.
- Leaders have appointed experienced and qualified teaching staff for both the primary and secondary phases of the school. A comprehensive staff training programme is in place. This is likely to help staff to understand the specific needs of pupils and be able to adapt and use different resources. Staff will also undertake training to ensure that



there is a consistent approach to managing behaviour. Systems are in place to monitor the quality of teaching, learning and assessment.

### Part 2. Spiritual, moral, social and cultural development of pupils

#### All paragraphs

- The school's policies show that spiritual, moral, social and cultural development is a core aspect of the curriculum and the ethos of the school. There is a strong focus on building relationships based on trust and respect. Leaders aim to increase pupils' selfesteem and help them to express and manage their emotions.
- Pupils will receive 'life coaching' and PSHE education through the well-structured 'Personal Development' programme. Pupils will have opportunities to discuss wideranging topics and explore other points of view.
- Plans show that pupils will learn about British values across the curriculum. Pupils will have themed days to learn about aspects such as democracy and the British parliament.
- Pupils will have a range of opportunities to learn about religious and cultural events throughout the school year. The 'creative curriculum' includes community-based service, charity work and programmes to develop pupils' leadership skills.
- This part of the independent school standards is likely to be met.

## Part 3. Welfare, health and safety of pupils

#### All paragraphs

- There are a number of policies in place to ensure pupils' health and safety, including first aid, risk assessment, admissions, behaviour and safeguarding. These are all in accordance with statutory guidance.
- The safeguarding and child protection policy is clear and detailed. It outlines the roles and responsibilities of staff and sets out the procedures staff should follow if they have any concerns about pupils. Designated safeguarding leaders have already received appropriate training and suitably qualified first aiders will be available on site at all times.
- The behaviour policy explains how staff will promote positive behaviour and use the whole-school rewards and consequences system. Types of behaviour specific to autism spectrum disorder are listed, with appropriate guidance and strategies for staff. The school will operate an anti-bullying charter so that any form of bullying will not be tolerated.
- The admissions and attendance registers contain all of the required information. Plans for the effective supervision of pupils are in place.
- Leaders have a clear understanding of relevant health and safety regulations to ensure that pupils will be safe on the school premises. The site complies with fire safety regulations. An additional fire risk assessment will be carried out in August

2020 to check fire safety equipment in the new kitchen area. A cycle of regular checks will help to maintain all aspects of safety.

## Part 4. Suitability of staff, supply staff, and proprietors

#### All paragraphs

- The single central register is in place and contains information on appointed staff. All the statutory checks to ensure the suitability of staff have been carried out. This includes checks on the proprietors and governors. Strong systems are in place to ensure that the single central register is kept up to date as the school expands.
- This part of the independent school standards is likely to be met.

#### Part 5. Premises of and accommodation at schools

#### All paragraphs

- Since purchasing the site, the proprietors have carried out a refurbishment of the school buildings in readiness for the school opening. There have been some delays due to COVID-19 (coronavirus) restrictions, but all work is due for completion by the end of August 2020.
- The premises provide ample space to accommodate the proposed number of pupils. Classrooms have all been fitted to a high standard. Heating, lighting and acoustics in rooms and internal spaces are all suitable. Pupils have access to outdoor space and a newly fitted canteen. Pupils will receive PE lessons off site at local sports centres.
- New toilets and washing facilities have been installed for pupils and staff. There is a dedicated medical room with appropriate equipment. Drinking water is available at various points in the school.
- This part of the independent school standards is likely to be met.

#### Part 6. Provision of information

#### All paragraphs

- The school's website is currently being revised. It will be a joint site for the proposed school and the proprietors' other school, Serenity School Croydon.
- All the required policies are currently in place and available on request.
- This part of the independent school standards is likely to be met.

#### Part 7. Manner in which complaints are handled

#### All paragraphs

- The complaints policy clearly sets out the procedures to follow and the different stages of managing and responding to a complaint, including timescales. The policy also includes arrangements for an independent person to form part of a panel that will hear any complaints.
- This part of the independent school standards is likely to be met.

### Part 8. Quality of leadership in and management of schools

## All paragraphs

- All the independent school standards are likely to be met. The proprietors already run a well-established independent special school in Croydon for secondary-aged pupils. At least two local authorities have expressed to them a need for more school places to cater for pupils with special educational needs and/or disabilities (SEND). The proposed school will be led and managed using the same structures in place at the original school.
- The newly appointed headteacher and head of the primary phase are both experienced primary school leaders. This will help leaders to implement the primary phase of this all-through school.
- The proprietors and the school's consultant will support the headteacher. There are clear lines of accountability in place to monitor and quality assure all aspects of the provision.
- This part of the independent school standards is likely to be met.

### Schedule 10 of the Equality Act 2010

- Leaders have an appropriate accessibility plan. The school site has suitable facilities and adaptations for disabled staff and pupils. Leaders are able to demonstrate how the curriculum will be adapted for the different needs of pupils.
- The school is likely to meet the relevant requirements under the Equality Act 2010.

- The school intends to open on 14 September 2020.
- Leaders do not intend to make use of alternative provision.
