Monitoring visit Inspected under the social care common inspection framework

Information about this children's home

This home is owned and managed by a local authority. The home provides care and accommodation for up to two children with complex needs.

Inspection date: 11 August 2020

This monitoring visit

A monitoring visit took place on 10 June 2020 where a number of shortfalls were identified. As a result, 12 requirements were made. Three of these requirements were subject to a compliance notice. Ofsted also imposed an urgent variation to the home's conditions of registration, reducing the number of children who can be cared for from four to two. At a subsequent monitoring inspection in June one of the compliance notices was met.

The purpose of this monitoring activity was to evaluate the provider's progress in meeting the compliance notices and to ensure that the provider is complying with the variation of condition of registration. Due to ongoing restrictions related to COVID-19 (coronavirus) this visit was completed remotely. The inspector was sent documents by email and spoke to children, parents, staff and other professionals using video conferencing and telephone calls. In addition to the compliance notices, nine requirements have been reviewed and have been met.

The variation of condition of registration has continued to be complied with, and there are two children living in the home.

Managers and staff now have clear plans in place to support children. Children are involved in writing these plans, which are truly child centred. They address all areas of children's lives and have realistic, measurable targets. This helps children to understand their strengths and needs and make progress. When there is delay to children's plans being implemented managers challenge this and advocate in



children's best interests. As a result, children know what they are working towards and staff challenge others to play their part in children's success.

The responsible individual and acting manager have introduced a framework to consider individual risks for children. This also incorporates clarity about staff training and skills to manage and reduce these risks. Managers and staff are better enabled to make informed decisions about children coming to the home and during their stay, and this keeps children safe.

The acting manager has ensured that there are sufficient skilled staff to meet the needs of children. These staff regularly seek children's views and respond appropriately. With the support of the responsible individual, the acting manager has simplified recording and monitoring systems. This has increased her oversight of practice and the experiences of children. Because of this, the acting manager is assured that children have child-centred, attuned relationships with adults who care deeply about their well-being.

As a result of these improvements the compliance notices in relation to regulation 13 and 14 are met.

Staff have completed work with children about personal relationships. The clear expectations laid down by staff have helped children to have more positive and supportive relationships with each other.

The acting manager has completed admission and discharge records; these now meet regulation. The acting manager has introduced a daily register so that it is clear when children may be staying away from the home and why. This means records are clear and children can understand the time they spend in the home.

The responsible individual has commissioned a new independent visitor who does not work for the local authority. His reports give the staff a constructive view of the home and makes his opinion about safeguarding and children's well-being clear. The acting manager responds to recommendations with a monthly action plan, which helps improve the quality of care children receive.

The acting manager has ensured that information of concern is shared with Ofsted as required. These notifications to the regulator show that staff know how to respond sensitively to children's information and that the acting manager understands the relevant regulations. This enables the regulator to have a more comprehensive view of the home.

The registered manager is currently away from the home and the deputy manager is acting as manager. Staff feel supported by the acting manager and she has worked hard to help staff successfully engage with improvement work. Staff are child centred and so have welcomed the simplified systems that have been put in place, as this means they can devote more time to children. The child-centred and



committed leadership enables staff to spend more time building good relationships with children, to meet their needs in attuned and creative ways.
