Information about this children's home

This home is owned and run by a private organisation. It is registered to provide care and accommodation for up to three children.

The home has been without a registered manager since May 2017.

This monitoring visit

The purpose of this monitoring visit was to assess whether the provider has complied with a restriction of accommodation placed on the home on 17 July 2020.

The terms of the notice served were that no child or young person may be accommodated at the children's home unless the child or young person was living there at the time we served the notice and has continued to be accommodated there since we served the notice. The home must not accept any new admissions while this restriction is in place, including if a child or young person already accommodated moves placement or leaves and is accommodated elsewhere for any period of time.

In accordance with Ofsted's guidance on COVID-19 (coronavirus) restrictions, this inspection was undertaken remotely. The monitoring visit took place on 26 August 2020. Information had been sent to Ofsted electronically on 25 August. A telephone discussion was held with the responsible individual on 26 August, and he confirmed that no children have been resident at this home since 21 June 2020. The scanned copy of the admissions and discharges book, provided to the inspector, confirmed the date when the last child left the home.

As a result of the information provided, Ofsted is satisfied that no children have been living in this home since 21 June 2020. The provider has complied with the restrictions placed on the service.

Recommendations

Staff should record information on individual children in a non-stigmatising way that distinguishes between fact, opinion and third-party information. Information about the child must always be recorded in a way that will be helpful to the child.
