Inspected under the social care common inspection framework

Information about this children's home

This is a privately run home for female children and young people aged between 11 and 18 years. It provides a therapeutic 12-month programme for children and young people who have experienced, or are at risk of, sexual exploitation.

The manager registered with Ofsted in July 2020.

This monitoring visit

A monitoring visit took place in response to safeguarding concerns reported to Ofsted.

The registered manager does not ensure that children's risk assessments are updated to reflect their statutory plans. For example, staff closely monitor one child regularly throughout the night as recorded in the child's risk assessment. However, the agreement with the placing authority is that these checks are not routine. While there has been no detriment to children through this additional level of monitoring, this inconsistency means that staff are unsure of their responsibilities.

Relationships between children are closely monitored. However, there is no evidence of staff completing any sessions with children about appropriate relationships. This means that children are unable to develop their skills and understanding regarding what safe relationships are.

The registered manager and deputy were added onto the rota to work shifts in the home. This could prevent them from having the necessary time to lead, manage or monitor the home effectively. This has led to a significant decline in the effectiveness and quality of the service.

A lack of staff affects the support that children receive and is harmful to their emotional well-being. For example, one child said that because staff were unable to manage other children's behaviours, she had been kept awake for a number of nights. The responsible individual and deputy manager put some interim measures in place during this visit to address this concern. However, an effective staffing strategy is required to provide children with safe and consistent support.

The registered manager and deputy manager do not always share key information about changes to children's support plans, with staff, in a timely manner. This means that care plans and risk assessments for some children are out of date, and this leads to inconsistent staff practice.

Managers did not demonstrate an understanding of the impact that poor-quality care has on children's progress and development. Managers do not use available information about children's behaviours or risks to tailor the service to meet all the children's individual and collective needs.

Since the last inspection, and when appropriate to do so, staff help children to learn the skills they need to prepare them for adulthood and independence. This addresses the requirement made at the last inspection.

Prior to the recent decline in some children's behaviours, most of the children had experienced a period of stability that enabled them to achieve.
