Monitoring visit Inspected under the social care common inspection framework

Information about this children's home

A private company owns this home. The statement of purpose states that care and accommodation are provided for up to two children, aged from eight to 18, who have emotional and behavioural difficulties.

There has been no registered manager since 30 June 2019.

This monitoring visit

A monitoring visit took place on 4 August 2020. It was found that a compliance notice in relation to regulation 12 was not met, and therefore reissued. The provider was required to take the necessary steps to meet the compliance notice by 20 September 2020.

An assurance visit took place on 23 September 2020. As a result of this visit, the compliance notice was reissued against regulation 12 and two requirements were made in relation to appointing a manager and working as a team. A restriction of accommodation notice was also issued.

This monitoring visit was conducted on site to assess the provider's progress in meeting the compliance notice, the requirements and the restriction notice, as well as to seek assurance about the safety and welfare of the child currently living in the home.

The inspector established that no other children, other than the one child already living in the home, have been accommodated since the previous monitoring visit. Consequently, the provider has complied with the restriction notice. No concerns were identified in respect of the immediate safety and welfare of the child currently in placement.



Compliance notice – Regulation 12 (1) (2)(a)(iii)

The provider was required to complete a full and thorough written review of all staff skills and competencies, identifying any gaps or shortfalls, and arrange the requisite training to ensure that staff are enabled to provide safe care for children.

Leaders and managers have made a significant effort to improve systems to meet the requirements of the compliance notice under regulation 12. They have ensured that the skills and competencies framework for staff has been completely redeveloped. They have created a dedicated and personalised format which much better reflects the needs of children in the home.

Staff are positive about the work they have been doing with managers on the framework and are clearly invested in it. They feel that it validates the work they are doing and sets ambitious but realistic goals for future training and development.

Leaders and managers have used the new skills and competencies framework as a basis for reviewing all internal induction, training, supervision and appraisal systems. They have created a coherent flow and sense of continuity throughout these documents.

This compliance notice is judged to have been met.

The new responsible individual is showing good leadership. She has picked up on the proposed quality assurance framework with advanced plans to implement this. She has appointed a new manager. The previous statutory requirements are met.

Senior leaders have restructured the organisation so that there are clear responsibilities and accountabilities to ensure that all of the staff work together as a team. They have reviewed staff job descriptions, but these currently lack the specific safeguarding responsibilities and roles in the decision-making process for admitting children into the home.
