Inspected under the social care common inspection framework

## **Information about this children's home**

This privately owned children's home is operated by a large national provider. It is registered to care for up to three children aged between 12 and 17 who have complex needs and have experienced trauma and loss.

The registered manager holds a level 5 diploma in leadership and management for residential childcare.

**Inspection date:** 17 November 2020

## **This monitoring visit**

Ofsted inspected the home on 13 and 14 October 2020. Serious and widespread concerns were identified. As a result, Ofsted took the decision to issue the home with a notice to vary a condition of the registration. Ofsted considered this to be the most appropriate action and believed that reducing numbers from five children to three, on an urgent basis for up to 12 weeks, would give managers and staff the opportunity to reduce the risk of harm that was present in the home. Additionally, Ofsted issued a compliance notice under regulation 13 (the leadership and management standard).

A monitoring visit was carried out on 3 November 2020 to review the notice to vary a condition of the registration. At this monitoring visit, inspectors found that, despite the number of children being reduced to three, children were not safe in the home. As a result of the significant concerns identified, Ofsted made the decision to issue a notice to suspend the registration of this home. This took immediate effect from 4 November 2020 until 26 January 2021.

The requirements raised at the inspection on 13 and 14 October 2020 have not been reviewed and therefore remain in place.

This monitoring visit was carried out to review the compliance notice and the suspension notice.

The provider has complied with the suspension notice and all children have moved out from the home. As a result of the suspension notice being issued, the steps in the compliance notice no longer apply.

The provider is working closely with Ofsted and has plans in place to refurbish the home during the period of suspension.

Ofsted will continue to monitor the home and will keep the suspension notice under regular review.
