### Information about this children's home

The home provides care and accommodation for up to two children who may have emotional and/or behavioural difficulties.

The home is managed by a private company and there is a qualified registered manager.

**Inspection date:** 18 November 2020

# This monitoring visit

This monitoring visit took place due to the recent inspection history. On 30 June 2020, two compliance notices were issued under regulation 12, the protection of children standard, and regulation 13, the leadership and management standard. On 13 August 2020, a monitoring visit was undertaken to monitor compliance with these notices. The provider met the compliance notices.

No serious or widespread concerns about the care and protection of children were found during this visit. Two children currently live at the home. Both children were positive about living in the home, and they described trusted relationships with staff. Observations of children's interaction with staff evidenced that relationships are positive.

Since the previous monitoring visit, one child has left the home and two children have moved in. The two children currently living at the home have a positive relationship, and the children told inspectors that they spend time with each other. One child told inspectors that they watch films together and go to the shops with staff.

However, the provider failed to demonstrate that they had carefully planned children's admissions in and through the children's home. Impact risk assessments do not robustly assess all known risk factors in respect of children. This means that the home's ability to meet prospective new residents' individual needs is not suitably

assessed or tested at the point of the child's admission. This was a requirement at the previous monitoring visit and is repeated.

Children's risk assessments contain relevant specific information that is individual to each child's needs. The risk assessments include the strategies that staff are expected to follow to reduce the risks. Furthermore, staff demonstrate that they follow children's risk assessments in practice.

However, the manager needs to ensure that children's risk assessments include all current risks and strategies for staff to follow to reduce risk. This is specifically in relation to risk assessments for children when they spend time with their family.

Further shortfalls were identified in the rota system. Rotas do not include the hours that the registered manager is working. A requirement was made to address this breach in regulation at the previous visit and is repeated.

The manager has addressed some of the requirements from the last inspection. However, requirements have been repeated. The manager recognises these gaps in practice and the identified areas for improvement.

The registered person must—	
maintain in the home the records in Schedule 4; and	
ensure that the records are kept up to date. (Regulation 37 (1) (2)(a)(b))	
In particular, ensure that the records include a copy of the staff duty roster of persons working at the home, a record of	



the actual rotas worked, and a record of any person who	
works at any time at the home.
