Information about this children's home

This privately owned children's home is operated by a large national provider. It is registered to care for up to three children who have complex needs and have experienced trauma and loss.

There is currently no registered manager in post.

Inspection date: 16 December 2020

This monitoring visit

Ofsted inspected the home on 13 and 14 October 2020. Serious and widespread concerns were identified. As a result, Ofsted took the decision to issue the home with a notice to vary a condition of the registration. Ofsted considered this to be the most appropriate action and believed that reducing numbers from five children to three, on an urgent basis for up to 12 weeks, would give managers and staff the opportunity to reduce the risk of harm that was present in the home. Additionally, Ofsted issued a compliance notice under regulation 13 (the leadership and management standard).

A monitoring visit was carried out on 3 November 2020 to review the notice to vary a condition of the registration. At this monitoring visit, inspectors found that, despite the number of children being reduced to three, children were not safe in the home. As a result of the significant concerns identified, Ofsted made the decision to issue a notice to suspend the registration of this home. This took immediate effect from 4 November 2020 until 26 January 2021.

This monitoring visit was specifically aimed at reviewing the suspension notice and was undertaken remotely.

The provider has complied with the suspension notice. The organisation is currently refurbishing the home.

The registered manager and responsible individual have both left the organisation. Recruitment is currently taking place to fill these roles. The staff are working in other homes in the organisation and are receiving further training and reflection.

Ofsted will continue to monitor the home and will keep the suspension notice under regular review.

The requirements raised at the inspection on 13 and 14 October 2020 have not been reviewed and therefore remain in place.

assess whether each child is at risk of harm, taking into account information in the child's relevant plans, and, if necessary, make arrangements to reduce the risk of any harm to the child;	
take effective action whenever there is a serious concern about a child's welfare and that the home's day-to-day care is arranged and delivered so as to keep each child safe and to protect each child effectively from harm;	
that the premises used for the purposes of the home are designed, furnished and maintained so as to protect each

The leadership and management standard is that the registered person enables, inspires and leads a culture in relation to the children's home that—	11 January 2021
helps children aspire to fulfil their potential; and	
promotes their welfare.	
In particular, the standard in paragraph (1) requires the registered person to—	
lead and manage the home in a way that is consistent with the approach and ethos, and delivers the outcomes, set out in the home's statement of purpose;	
ensure that staff work as a team where appropriate;	
ensure that staff have the experience, qualifications and skills to meet the needs of each child;	
ensure that the home has sufficient staff to provide care for each child;	
understand the impact that the quality of care provided in the home is having on the progress and experiences of each child and use this understanding to inform the development of the quality of care provided in the home. (Regulation 13 $(1)(a)(b)(2)(a)(b)(c)(d)(f)$)	
The care planning standard is that children receive effectively planned care in or through the children's home.	11 January 2021
In particular, the standard in paragraph (1) requires the registered person to—	
ensure that children are admitted to the home only if their needs are within the range of needs of children for whom it is intended that the home is to provide care and accommodation, as set out in the home's statement of purpose;	
that arrangements are in place to ensure the effective induction of each child into the home. (Regulation 14 $(1)(a)(2)(b)(i)(ii)$)	
No measure of control or discipline which is excessive, unreasonable or contrary to paragraph (2) may be used in relation to any child. (Regulation 19 (1))	11 January 2021



The registered person must ensure that—	11 January 2021
any limitation placed on a child's privacy or access to any area of the home's premises is intended to safeguard each child accommodated in the home;	
is necessary and proportionate;	
is kept under review and, if necessary, revised;	
allows children as much freedom as is possible when balanced against the need to protect them and keep them safe. (Regulation 21 (c)(i)(ii)(iii)(iv))	
In particular, the appropriateness of using bedroom door alarms needs to be fully considered and kept under review.	
The registered person must ensure—	11 January 2021
that all employees undertake appropriate continuing professional development;	
receive practice-related supervision by a person with appropriate experience. (Regulation 33 (4)(a)(b))	
The registered person must prepare and implement a policy ("the behaviour management policy") which sets out—	11 January 2021
how appropriate behaviour is to be promoted in the children's home;	
the measures of control, discipline and restraint which may be used in relation to children in the home.	
The registered person must ensure—	
that within 24 hours of the measure of control, discipline or restraint in relation to a child in the home, a record is made which includes—	
the effectiveness and any consequences of the use of the measure. (Regulation 35 (1)(a)(b)(3)(a)(vii))	
The registered person must notify HMCI and each other relevant person without delay if—	11 January 2021
an incident requiring police involvement occurs in relation to a child which the registered person considers to be serious;	
there is an allegation of abuse against the home or a person working there; or	
there is any other incident relating to a child which the registered person considers to be serious. (Regulation 40 $(4)(b)(c)(e)$)	



Recommendations

■ Some records may be kept electronically (regulation 38) provided that this information can be easily accessed by anyone with a legitimate need to view it and, if required, be reproduced in a legible form. Electronic records should be held at the individual home in accordance with data protection principles. IT systems should ensure the safe storage of these records and business continuity planning should be in place to prevent loss or damage to them.
