Inspected under the social care common inspection framework

Information about this children's home

This privately-owned children's home is operated by a large national provider. It is registered to care for up to three children who have complex needs and have experienced trauma and loss.

There is currently no registered manager in post.

Inspection date: 19 January 2021

This monitoring visit

Ofsted inspected the home on 13 and 14 October 2020. Serious and widespread concerns were identified. As a result, Ofsted took the decision to issue the home with a notice to vary a condition of the registration. Ofsted considered this to be the most appropriate action and believed that reducing numbers from five children to three, on an urgent basis for up to 12 weeks, would give managers and staff the opportunity to reduce the risk of harm that was present in the home. Additionally, Ofsted issued a compliance notice under regulation 13 (the leadership and management standard).

A monitoring visit was carried out on 3 November 2020 to review the notice to vary a condition of the registration. At this monitoring visit, inspectors found that, despite the number of children being reduced to three, children were not safe in the home. As a result of the significant concerns identified, Ofsted made the decision to issue a notice to suspend the registration of this home. This took immediate effect from 4 November 2020 until 26 January 2021.

A further monitoring visit took place on 16 December 2020 to review the suspension notice. The inspector found that the provider had complied with the suspension notice and the home was being refurbished. The registered manager and responsible individual had left the organisation.

This monitoring visit was specifically aimed at reviewing the suspension notice and was undertaken remotely.

This visit found that the provider has continued to comply with the suspension notice. The provider does not plan to admit children until the senior managers action plan is implemented. Ofsted will keep this under review.

The requirements raised at the previous inspections have not been reviewed and therefore remain in place.

<p>The care planning standard is that children receive effectively planned care in or through the children's home.</p> <p>In particular, the standard in paragraph (1) requires the registered person to ensure—</p> <p>that children are admitted to the home only if their needs are within the range of needs of children for whom it is intended that the home is to provide care and accommodation, as set out in the home's statement of purpose;</p> <p>that arrangements are in place to ensure the effective induction of each child into the home. (Regulation 14 (1)(a)(2)(b)(i)(ii))</p>	<p>22 February 2021</p>
<p>No measure of control or discipline which is excessive, unreasonable or contrary to paragraph (2) may be used in relation to any child. (Regulation 19 (1))</p>	<p>22 February 2021</p>

<p>The registered person must ensure that—</p> <p>any limitation placed on a child's privacy or access to any area of the home's premises is intended to safeguard each child accommodated in the home;</p> <p>is necessary and proportionate;</p> <p>is kept under review and, if necessary, revised;</p> <p>allows children as much freedom as is possible when balanced against the need to protect them and keep them safe. (Regulation 21 (c)(i)(ii)(iii)(iv))</p> <p>In particular, the appropriateness of using bedroom door alarms needs to be fully considered and kept under review</p>	<p>22 February 2021</p>
