Monitoring visit Inspected under the social care common inspection framework

Information about this children's home

This is one of a number of privately run children's homes. It is registered for four children with emotional and/or behavioural difficulties.

Children placed at this home can access the organisation's registered school and therapeutic services.

The manager was registered in February 2018 and holds the level 5 diploma.

Inspection date: 18 January 2021

This monitoring visit

This monitoring visit took place due to increasing concerns arising from review of regulation 40 notifications and regulation 44 independent visitor reports. The concerns specifically relate to a serious safeguarding allegation of a child being sexually assaulted by another child, an allegation that a child was punched in the face during a physical intervention by staff and a very serious incident where two children went missing from staff and rode their scooters on the hard shoulder of the M6 motorway. There had also been late notification of a medication error where a child was given a double dose of his prescribed medication.

Children's risk assessments were reviewed due to increases in their risk levels. The inspector identified that the scoring system used to rate risks was not being correctly implemented. This led to risks being wrongly judged to be lower than they actually were. For example, a child who has a serious sexual assault alleged against him had a risk rating of 'low' for sexually harmful behaviours. Managers had not identified these errors through their monitoring systems. Not all risk assessments were up to date. This included the missing-from-care risk assessment for one of the children who had put themselves in extreme danger on the local motorway. Other information was missing from risk assessment documents. For example, one child had clearly been influenced by a peer to go missing but this was not recorded in the



'push and pull' section of his missing-from-care procedure. Another missing-fromcare procedure did not contain any information about the child's most recent missing-from-home episode. Errors and omissions in risk assessments potentially leave staff without the relevant knowledge to safeguard the children.

The home has a location risk assessment in place. This has not been revisited since the two boys were found on the motorway. It states that the M6 is four miles from the home, however this is not the case. The children accessed the motorway in a very short space of time from going missing, via alternative quicker routes. This should have been recorded in the location risk assessment so that staff are aware of the significant risk of the proximity of the motorway to the home.

One child has recently been admitted to the home. The matching document for this child did not evidence that he had been visited by members of staff from the home, nor that he had visited the home prior to being placed there. Documentation from his previous care home showed that he had, in fact, been visited twice and had also had a visit to this home, but the home's record did not reflect this.

The admission of one child has caused disruption and resulted in another child displaying behaviours not previously seen. Incident levels have increased, as have physical interventions and assaults on staff. Managers state that not all staff have the skills to de-escalate or manage these more extreme behaviours. The home's manager and the deputy manager have, therefore, been spending time helping staff to care safely for the children. This has resulted in some managerial tasks being overlooked. Specifically, this relates to managerial oversight of documents.

Management of allegations has not been robust. The designated officer has not been informed when incidents have occurred. An internal investigation into an allegation that a child was punched in the nose during a physical intervention had an outcome of no further action. Neither the designated officer, nor Ofsted, consider this to be appropriate. This is because the child did sustain a burst nose. There were clearly some 'lessons learned' and further strategies needed to support both the child and staff. These should have been identified as actions in the outcomes section of the report.

There has been a medication error where a child was administered his dose of medication twice. This was entirely preventable had the member of staff followed the home's procedure for the administration of medication.

This inspection has resulted in several requirements being made. Managers at the home and senior managers within the company accept the shortfalls identified. They are keen to work with the regulator to ensure that the standards of care and safety are returned to their former high level. An action plan has been shared with the lead inspector detailing how each shortfall will be addressed.



This inspection did not examine the home's response to requirements made at the ast full inspection. Therefore those requirements made have remained in place and will be considered at the next full inspection of the home.
