### **Autonomy Plus Limited**

### Information about this children's home

This home is operated by a private company. The home can accommodate five children or young people who have learning disabilities.

The manager has been registered with Ofsted since 10 October 2020.

At the time of this monitoring visit, four young people were living in the home.

This home was last inspected in September 2019.

## This monitoring visit

This monitoring visit was completed because the home has not been inspected since September 2019. In addition, the independent visitor is not submitting their reports to Ofsted in a timely manner and they did not visit the home in December 2020. The requirements set at the previous inspection were also reviewed.

The inspector completed this visit remotely. The visit included a review of records, interviews with staff and video discussions with young people, who also gave the inspector a virtual tour of the home.

Young people like living at the home and each young person has an allocated education provision, either at school or college. The young people enjoy a wide range of fun and purposeful activities. Imaginative activities have taken place during the COVID-19 (coronavirus) lockdown restrictions. One young person shared with the inspector a video they have made with staff, in which they danced and sang along to their favourite song.

Young people's plans are of good quality, and provide clear guidance for staff on how to meet each young person's needs. Consequently, young people are making

progress, particularly with their independence skills. Staff spoke with pride about the young people's achievements.

Staff involve young people in the development of their support plans by using creative approaches, including the use of alternative communication systems. One young person recently produced a PowerPoint presentation for their review, to express their views.

Staff manage young people's behaviour well. During the summer, there was an increase in the number of incidents for one young person, but these have now decreased in number because staff have reflected on these incidents and developed different approaches. Records of incidents are of good quality, and include conversations between staff and young people after the event.

On occasions, staff use institutional language within the records they complete, which does make these records helpful and meaningful to the young people.

Staff take swift and appropriate action regarding safeguarding concerns, which protects young people. However, records of safeguarding events require improvement. Although it is possible to evidence that appropriate actions are taken in a timely manner, the information is not collated in one place. This does not help managers to monitor these records.

Staff are managing the effects of the COVID-19 pandemic well. They have undertaken individual sessions with the young people to develop their awareness of how to keep themselves safe. Staff have built a visitors' pod in the house, which provides a comfortable place for visitors while protecting everyone.

Leaders and managers have met three out of the four previous requirements and the recommendation set at the previous inspection. The requirement that has not been met relates to the independent visitor, and remains a shortfall that was identified at this visit. The independent visitor is failing to send their reports to leaders and managers and to Ofsted in a timely manner. In addition, they did not carry out a visit in December 2020. This does not help the leaders and managers in their development of the home. Furthermore, it means that Ofsted is not being provided with a key tool for monitoring the service. Leaders and managers have raised this with the independent visitor previously, and are taking action to address the ongoing concerns.

## **Statutory requirements**

upon request, the local authority for the area in which the home is located;

the placing authorities of children;

the registered provider and, if applicable, the registered manager. (Regulation 44 (1) (2)(a) (7)(a)(b)(c)(d))

In particular, ensure that the reports are sent to HMCI, the registered provider and the registered manager in a timely manner.

#### Recommendations

■ The registered person should ensure all staff understand the importance of careful, objective and clear recording. Records must always be written in a way that is helpful to the child. ('Guide to the children's homes regulations including the quality standards', page 62, paragraph 14.4)
