Monitoring visit Inspected under the social care common inspection framework

Information about this children's home

This privately owned children's home provides residential care for up to three children, aged eight to 17, who have a diagnosed learning disability.

The manager has been registered with Ofsted since July 2019.

Inspection date: 5 February 2021

This monitoring visit

The purpose of the monitoring visit was to establish whether there is effective leadership and managerial monitoring of practice and recruitment, following concerns raised to Ofsted. The visit comprised a blended approach of on-site and off-site activity. No serious concerns about children's care or welfare were identified. However, there are some regulatory shortfalls.

Since April 2020, three children have lived at the home. The children are settled and all attend school. Children benefit from individual routines in accordance with their needs.

The house provides the children with communal living space and personalised bedrooms and has a small rear garden. The garden is not well kept; the general upkeep has been overlooked by the manager. Consequently, the children do not benefit from a pleasant outdoor space. This is particularly notable when local facilities are closed because of COVID-19 (coronavirus) restrictions.

The children benefit from a consistent staff team. Any vacancies are recruited to without delay. However, the recruitment checks are not thorough enough. References that identify previous concerns are not properly explored. Risk assessments for some staff are not objective and fail to address the specific risk. This does not provide good enough assurance about staff's suitability to work at the home.



The manager does not use agency staff. Due to COVID-19 infection, the registered manager and staff have covered any gaps in the rota. This avoids the need to have additional people coming into the home and reduces the risks of transmission. The consistent use of core staff helps children to build relationships and trust with the staff.

The staff training programme has been affected by the COVID-19 pandemic. Recent behaviour management training was cancelled. This means that refresher training for some staff is overdue.

Supervision is provided regularly by senior staff. However, one supervisor failed to pick up concerns raised by a new member of staff during a supervision meeting. This could result in safeguarding concerns not being explored.

Statutory requirements

The registered person may only—	
if an individual is employed by a person other than the registered person to work at the home in a position in which the individual may have regular contact with children, allow that individual to work at the home, if the individual satisfies the requirements in paragraph (3).	
The requirements are that—	
full and satisfactory information is available in relation to the individual in respect of each of the matters in Schedule 2. (Regulation 32 (1) (2)(b) (3)(d))	



This specifically relates to the provider undertaking comprehensive recruitment checks and risk assessments for staff.

Recommendations

The registered person should ensure that supervision of staff safeguards the children and minimises potential risks to them. In particular, the supervisor should pick up and follow through any issues of concern. ('Guide to the children's homes regulations including the quality standards', page 61, paragraph 13.1)
