Monitoring visit Inspected under the social care common inspection framework

Information about this children's home

This is a privately owned children's home that provides care and accommodation for a maximum of three children aged between 10 and 17 years. The home cares for children who may have emotional and/or behavioural difficulties.

Inspection date: 3 February 2021

This monitoring visit

This monitoring visit was undertaken to review concerns about staffing. This visit explored whether staff have the necessary skill set and level of experience to meet the needs of the children in their care, and to consider the impact of high staff turnover. This visit also reviewed the matching processes to ensure children can live together in the home safely.

The registered manager was not able to work at the home for an extended period, resulting in management shortfalls.

Despite an interim manager being in post during the registered manager's absence, some staff have felt unsupported. This has contributed to high levels of staff turnover.

The staff team stabilised following the return of the manager. A deputy manager has also been appointed. Despite high staff turnover, a core staff team remains in place and is able to meet the needs of each child. Managers are actively recruiting new staff.

Managers have implemented therapeutic training for staff. This has improved the way that staff communicate with children. However, not all staff have had this training. There have been examples of staff using language that could result in a child feeling stigmatised. Despite this, parents and professionals described the staff



as 'outstanding'. One professional said, `The whole team is motivated and devoted to the children. I could really see the love from all the staff.'

Children who move into the home are carefully matched to live alongside the children already resident and a thorough risk analysis is undertaken. As a result, transitions for children are good.
