Monitoring visit
Inspected under the social care common inspection framework

Information about this children's home

This home provides care and accommodation for up to four children and young people with a variety of complex needs and who are aged seven to 17 years old.

A private provider operates the home.

The registered manager is suitably experienced and holds a level 5 qualification in leadership and management. However, he has recently submitted his application to voluntary cancel his registration with Ofsted and is due to leave this role on 12 February 2021. The company has appointed an interim manager to lead the home while it completes the recruitment process to appoint another manager.

This monitoring visit

This visit was carried out due to concerns raised by the independent visitor that staff have been unable to prevent children causing harm to each other. Furthermore, children have made allegations about staff following incidents and there are concerns about the physical environment and level of damage to the home.

Due to the COVID-19 (coronavirus) pandemic, Ofsted completed a risk assessment and made the decision to visit the home. Ofsted last inspected the home in February 2020 at an interim inspection, when the home was judged to have sustained effectiveness; at the home's first inspection in 2019, it was judged to be good.

There are currently three children living in the home. Since the last inspection, two children have left and one child has moved into the home. These moves were planned and the transition periods for children were managed effectively.

There is a consistent staff team in the home and there is a current recruitment process in place to cover vacancies. Staff work hard to develop and maintain supportive relationships with children. Inspectors observed staff supporting children

with their education and engaging in activities with children during the visit. As a result, children develop strong and trusting relationships with staff. Staff support children to attend school and engage with their learning. Where children have not had a school place, staff and managers have worked with external professionals to secure an appropriate school place. An external professional informed inspectors that she was really pleased with how staff support one child's learning.

The national lockdown has resulted in children having restrictions imposed on their everyday lives. Staff report that this period is difficult for children and this has led to an increase in incidents in the home. To counter this, staff have been creative and introduced activities to engage children. For example, a ping-pong table has been created in the home, and one child informed the inspectors that he was the 'ping-pong champion'. In addition, staff have used the time to support children to identify and plan for life for when restrictions are removed. One child informed the inspectors that she had been accepted into the police cadets and will start in April 2021. This means that children feel valued.

While some parts of the home are homely and personalised, this is not consistently the case. Many areas of the home are damaged and have not been repaired effectively. Furthermore, there have been some delays in getting the work completed. However, the management team is taking action to address this and there is now a plan in place to ensure the work is completed promptly.

Staff have managed some significant incidents with children well. The registered manager has also ensured that reflection has taken place to identify areas where practice can be improved. However, during other incidents, the behaviour management strategies used by staff have been inappropriate. On one occasion, staff offered financial rewards to a child to manage physical aggression. Furthermore, staff failed to intervene or respond effectively to safeguard a child when in distress. Consequently, this led to a member of staff receiving significant injuries and the police being called to the home. On another occasion, staff have used physical restraint to manage children's behaviour. These measures were used as a last resort and to keep children safe. However, the staff involved had not received training in physical restraint practice and, consequently, the actions taken were ineffective. These shortfalls have impacted on the safety of children in the home.

Since the last inspection, there have been bullying incidents between children. Staff explained to inspectors the strategies they use to prevent children from harming each other. For example, staff have completed key-work sessions and have held direct discussions with children. These have helped children to understand the impact of their behaviour and learn from incidents. The inspectors found that these strategies were also recorded in children's risk assessments. This approach has ensured that incidents between children have reduced.



Some management oversight and monitoring systems used are satisfactory. However, there are shortfalls in the recording of key incidents which have not been addressed or identified by the registered manager. Senior leaders have recognised these shortfalls and have a plan in place to improve leadership and management in the home.

The registered manager has not submitted an up-to-date version of the home's statement of purpose to Ofsted. The statement of purpose has failed to include details of the experience and qualifications of staff working in the home. This compromises the reader from having accurate information about the staff working in the home.
