### Information about this children's home

The home is owned by a private provider and offers care and accommodation for up to three children. The provider states in its statement of purpose that care is provided for children and young people with social, emotional or behavioural difficulties.

The registered manager resigned on 9 December 2020. A new manager has been appointed and is in the process of registering with Ofsted.

# This monitoring visit

On 8 December 2020, a restriction notice was imposed in relation to safeguarding concerns received by Ofsted. A monitoring visit took place 11 January 2021. Ofsted reported that leaders and managers were working well to address points on their action plan.

This visit was undertaken to monitor the progress made and to monitor the restriction notice.

Two young people currently live in the home.

The visit was conducted remotely and included telephone discussions with the manager and a new member of staff. In addition, the inspector remotely reviewed records.

Leaders and managers have continued to progress their action plan. A qualified and experienced manager has been appointed and his application to register with Ofsted is in progress.

The manager has been instrumental in recruiting new staff and stabilising the staff team. A review of practice, recording and reporting by the manager has resulted in a

more efficient and effective approach to safeguarding.

Staff receive regular supervision and training opportunities. One new member of staff spoke positively of the support from the new manager and the improved morale of the staff team.

Staff are consistent in how they support the young people. This has resulted in the young people being better supported when they are upset. Since the previous monitoring visit, there have been no safeguarding or notifiable incidents and no use of physical intervention.

Young people living in the home are settled and making progress. A good choice of activities enables them to remain focused on their learning.

Leaders and managers have taken positive dynamic action to address the statutory requirements made following the monitoring visit on 8 December 2020. Because of this work, requirements made at the previous monitoring visit are met.
