## Action For Children

Monitoring visit

Inspected under the social care common inspection framework

### Information about this children's home

This children's home is run by a registered charity. The home is registered to provide care and accommodation for 11 children who may have learning disabilities and/or a physical disability. The service is provided in two separate houses. One house provides care and accommodation for up to four children under short-break arrangements and up to two children to live permanently. The other house provides care and accommodation for up to five children to live permanently.

The home's registration is currently subject to a notice of restriction of accommodation. This means that no new admissions and no short breaks are permitted. The children who lived at the home at the time of the notice may continue to live there.

The home has been without a registered manager since January 2020.

### This monitoring visit

The main purpose of this monitoring visit was to check the home's compliance with the notice restricting accommodation.

This enforcement notice was issued on 26 November 2020 under section 22B of the Care Standards Act. The notice followed the monitoring visit that was completed on 20 November 2020. During that visit, significant shortfalls were identified and 12 requirements were raised.

The notice restricting accommodation is in force until 18 February 2021. Meanwhile, the home and the notice are subject to Ofsted monitoring and review.

The outcome of this monitoring visit is that the provider is complying with the enforcement notice. No new admissions have been made to the home since the last monitoring visit.

Two children have successfully transferred to an adult care provider on the 11 February 2021. One child continues to be cared for at the home with a planned moving date of the 18 February 2021.

The provider intends to voluntarily cancel this home. A voluntary cancellation form was received by Ofsted on the 4 February 2021. This registration cancellation will become effective as soon as the remaining child moves out of the home.

Leaders and managers acknowledged that despite providing additional training for staff, there have been no changes or improvements in practice. This position is confirmed by the most recent independent monitoring report. Leaders and managers have reflected on this process and are reviewing the quality of care they provide in all their homes.

All the requirements set at the last visit have been repeated below.

<p>The registered person must complete a review of the quality of care provided for children ("a quality of care review") at least once every 6 months.</p> <p>In order to complete a quality of care review the registered person must establish and maintain a system for monitoring, reviewing and evaluating—</p> <p>the quality of care provided for children;</p> <p>the feedback and opinions of children about the children's home, its facilities and the quality of care they receive in it; and</p> <p>any actions that the registered person considers necessary in order to improve or maintain the quality of care provided for children.</p> <p>After completing a quality of care review, the registered person must produce a written report about the quality of care review and the actions which the registered person intends to take as a result of the quality of care review ("the quality of care review report").</p> <p>The registered person must—</p> <p>supply to HMCI a copy of the quality of care review report within 28 days of the date on which the quality of care review is completed; and</p> <p>make a copy of the quality of care review report available on request to a placing authority, if the placing authority is not the parent of a child accommodated in the home.</p> <p>The system referred to in paragraph (2) must provide for ascertaining and considering the opinions of children, their parents, placing authorities and staff.</p> <p>(Regulation 45 (1)(2)(a)(b)(c)(3)(4)(a)(b)(5))</p>	<p>21 March 2021</p>
