Information about this children's home

The home is part of a large charitable organisation. The home provides care and accommodation for up to three children who may have learning disabilities.

The manager has been registered with Ofsted since May 2020.

Inspection date: 2 March 2021

This monitoring visit

This visit was completed off site. The purpose of the visit was to ensure that children are safe and that their needs are being met. The home has not been inspected since 16 April 2019.

Suitable action has been taken to address the three requirements from the last inspection. The home continues to use a 'locked-door policy'. This is proportionate to managing the risk of children exiting out onto a road. Use of this measure is reflected in children's plans and recorded appropriately. The team is much more stable than previously reported. This has provided children with better continuity of care. Copies of statutory documents are now on file.

A recommendation from the previous visit is carried over. This recommendation relates to medication management and was not considered during this visit.

Children are cared for by a dedicated and competent team of staff. The staff are led by a manager who is child focused and ambitious for the children living at the home. A parent described him as being 'solution focused, and always wanting to improve opportunities for the children in his care'.

Feedback from parents and professionals is very complimentary about how children are supported and the progress they make. One social worker said, 'The staff take a really joined-up approach and make sure everybody that needs to be involved in care planning is.' The social worker also said, 'I am more than happy with the care

and support offered to [name of child]. [Name of child] is very settled and making very good progress.'

The inspector was given a virtual tour of the home. Communal areas have been decorated in a way that provides a stimulating environment for children with sensory needs. This theme continues in children's bedrooms, which are personalised and child friendly. One social worker said, 'The home is lovely and [name of child] is free to move around her home. [Name of child] especially likes the sensory room and spends lots of time in there. The home is geared up to care for children with complex needs.'

Children's safety is given a high priority. High staffing ratios provide children with the necessary support to keep them safe. Detailed risk management plans are understood and implemented by staff. These are kept under constant review to ensure that the strategies being used are effective in reducing risk. For example, staff have supported a child to better manage and reduce sexualised behaviour, despite not being trained in this area.

There has been one allegation since Ofsted last visited the home. Suitable action was taken including referral to the designated officer. However, in-house records were incomplete and did not provide evidence of the decisions made by external safeguarding professionals or the outcome of the incident. This information was acquired later during the visit from elsewhere in the organisation.

('Guide to the children homes regulations, including the quality standards', paragraph 7.15, page 35)
