Information about this children's home

This is a privately owned children's home. It is registered to provide care and accommodation for up to two children who may have emotional and/or behavioural difficulties.

The registered manager is no longer in post. He has not submitted an application to cancel his registration voluntarily.

This monitoring visit

This visit was arranged due to information in recent notifications. This is in respect of children making allegations against staff and concerns in respect of the staffing arrangements in the home. There is no registered manager or responsible individual in post.

The previous manager has not submitted an application to cancel his registration. An interim manager is currently managing the home. He submitted an application to Ofsted in January 2021. The acting responsible individual has also submitted an application to Ofsted.

This visit was completed on site. Two children live at this home. Inspectors spoke to both children, who were positive about their home. They both describe good relationships with staff.

The inspectors identified shortfalls in risk assessments and risk management plans. Children's risk assessments are not always updated. This means that staff do not have access to the most up-to-date information in respect of children. Risk assessments do not include clear strategies for staff to manage children's presenting risks; for example, the use of mobile phones, internet use and children's time in the community.



There are omissions in the manager's overall monitoring and review systems. This means that the manager cannot analyse and evaluate children's care to improve outcomes. For example, the manager's oversight of children's risk assessments and risk management plans needs to improve so that staff have access to effective risk management strategies to follow in practice.

Reports from the independent visitor have frequently been submitted late. The quality of reporting is often poor, and the reports do not include consultation with children, their parents and stakeholders. This means that the provider and the regulator are unable to assess the quality of care received and be satisfied by the leadership and management in the home.

Recording within the home needs to improve to ensure that all relevant details are recorded in children's case records. For example, staff need to ensure that all records are accurate, up to date and include all actions taken.

Children recently made allegations against staff members. These allegations have been managed appropriately and actions completed in a timely manner.

Supervision records demonstrate that staff receive good-quality supervision. Supervision sessions give staff an opportunity to discuss any personal issues and development needs.

are signed and dated by the author of each entry.

The registered person must use reasonable endeavours to ensure that an independent person visits the children's home at least once each month.	7 May 2021
The independent person must produce a report about a visit ("the independent person's report") which set out, in particular, the independent person's opinion as to whether—	
children are effectively safeguarded; and	
the conduct of the home promotes children's well-being.
