Monitoring visit Inspected under the social care common inspection framework

## Information about this children's home

The home provides accommodation and specialist care for adolescent males with histories of trauma, disrupted attachments and harmful sexual behaviour. It is registered to provide care and accommodation for up to four children. The organisation has its own separately registered school and therapeutic team.

The manager has been registered with Ofsted since July 2018.

## This monitoring visit

This visit took place due to the length of time since the previous inspection and information received by Ofsted relating to the condition of the property. The home was last visited on 15 May 2019, when a full inspection was carried out.

This visit was undertaken over two days. Day 1 was undertaken remotely by one inspector, in line with COVID-19 (coronavirus) risk management strategies. Day 2 was undertaken on site by two inspectors, due to serious concerns that had been identified during day 1. During this visit, the inspectors spoke with staff, two children and two social workers.

This visit was compromised by the resistance of the registered manager and the organisation's head of care to supply the inspectors with requested information. Consequently, the inspectors were unable to determine if the children were being suitably and safely cared for.

The inspectors attempted to case track one particular child from the four children currently living in the home. This was due to Ofsted's recent receipt of notifications from the provider, which detailed serious safeguarding incidents in respect of this child. Despite the registered manager's refusal to supply requested documents, the inspectors found the following serious gaps and omissions:



- the staff team's failure to adequately supervise this child has provided opportunities for the child to engage in dangerous and criminal behaviours
- in spite of the three recent serious safeguarding incidents, this child's care plan has not been updated. The last update of the care plan preceded these incidents
- the child's risk assessments and risk management plans do not provide staff with clear strategies on what they should do to keep the child safe
- despite an attempt by the child to self-harm through the use of ligatures, the child's bedroom was observed to have a number of potential ligature points. Inspectors were not provided with evidence that showed that sufficient action has been taken to reduce these risks
- inspectors were not provided with evidence to demonstrate that the required 15-minute observations by staff were taking place to monitor this child
- investigations into serious or safeguarding incidents have not always been undertaken or investigated to an acceptable standard
- the provider's strategies have not been effective in supporting this child to address their behaviours.

From the evidence seen, the inspectors were not convinced that the provider's risk management guidance is either well informed or implemented in practice to minimise the risks and protect this child from harm.

Leaders and managers have failed to oversee and manage the home effectively to ensure that it operates in line with its statement of purpose. From the limited evidence shared by the registered manager and the head of care, the inspectors determined that:

- leaders and managers have failed to ensure that the physical environment is maintained to an acceptable standard. The home is unkempt and is not cleaned adequately by staff. Kitchen equipment is unhygienic. The utility room has clear signs of mould and limescale on the walls. One child's bedroom is unhygienic and is furnished with broken furniture, including the child's bed
- the registered manager has failed to support one child to develop their independence according to the home's set procedures. This has left the child feeling undervalued with regards to the effort he has made to meet the requirements of his placement in the home.

Leaders and managers have not taken effective and timely steps to address the requirements set at the previous full inspection. They have not been effective in prioritising, challenging and making improvements to the home. The registered manager has failed to identify and address weaknesses in practice and demonstrate her capacity to keep children safe.



Ofsted has serious concerns about the provider's reluctance to share information with the regulator. Ofsted has issued a compliance notice in respect of the immediate safeguarding concerns for one child. Ofsted will consider its next steps in relation to concerns about the provider's wider practice and unwillingness to work with the regulator.
