Monitoring visit Inspected under the social care common inspection framework

Information about this children's home

This home is operated by a private provider. It is registered to provide care for up to four children who may have emotional and/or behavioural difficulties.

The home is overseen by an experienced manager who has been registered with Ofsted since November 2017.

This monitoring visit

This visit was instigated due to an increase in safeguarding notifications submitted to the regulator. These notifications largely relate to incidents in the home that have required police assistance. Additionally, there have been two occasions when a child was admitted to hospital. The inspector completed this visit remotely.

Over recent months, children living at the home have been facing difficulties, because of their own personal circumstances, exacerbated by the restrictions in place due to the COVID-19 (coronavirus) pandemic. This has led to an escalation in incidents in the home that have necessitated police support.

During these times, staff have maintained children's safety. Unfortunately, staff have been at risk of significant harm due to the behaviours displayed by children. This has led to a breakdown in children's placements. Decisions to end placements were not taken lightly, and clear attempts were made to maintain these placements prior to breakdown.

Police assistance was requested on several occasions to support the management of children's behaviours. On some occasions, this could have been avoided. The registered manager acknowledges that children's behaviours could have been better managed. As a result of this, she has accessed further training and development for newer members of the staff team who lack experience.



Meetings and reflective sessions are held regularly. These provide staff with an environment for learning and open discussion in which to improve their behaviourmanagement skills and discuss strategies. This helps to support children at times of crisis and prevent future incidents.

Despite the frequency and escalation of incidents in the home, children are well matched. Robust impact risk assessments are completed prior to children moving into the home. These appropriately assess any risks arising from children living within a group setting and include clear strategies to minimise and mitigate those risks identified.

Long-standing staff are confident in their roles and know children well. However, other staff have said that they would benefit from a designated person to contact for advice and guidance. This would support staff to manage challenging situations more confidently and effectively, and reduce the need for police involvement. A recommendation has been made to address this.

Staff are familiar with the home's whistle-blowing and safeguarding procedures. They have confidence in senior leaders and managers and feel able to openly discuss concerns or worries. This helps to ensure children's safety.

During the previous inspection, it was identified that independent monitoring reports were not submitted to the regulator within the required timescales. This prevents oversight from the regulator. There has been a further occasion when a report was not submitted. Because of this, this requirement has been repeated.
