#### Information about this children's home

This home, which is a limited company provides care and accommodation for up to six children who have emotional and/or behavioural difficulties. The registered manager has considerable experience and is suitably qualified for the position held.

### This monitoring visit

Due to the restrictions in place relating to the COVID-19 (coronavirus) pandemic, this visit was carried out off site. The visit was to investigate potential breaches of regulations. The visit included a review of documents, a virtual tour of the building and discussions with a child and staff.

Staff work hard to build positive relationships with the children in their care. In turn, the children learn to trust the staff. This allows the staff to then use a therapeutic parenting approach to start to address past traumatic experiences.

There is a strong ethos of listening to and consulting with children. Children engage well in direct discussions with the staff about their feelings, views and opinions. The children's views are considered and influence their care plans and the support that they require going forward.

Children benefit from living in a positive environment that provides them with a safe and secure home. The home is decorated, personalised and furnished to a high standard throughout. More recently, the garden space has been developed to include a large seating area and summer house that has been essential during the COVID-19 pandemic.

Staff take swift action after the occurrence of all serious incidents to safeguard children. This has included implementing missing from care protocols, seeking police

intervention, health services, and calling multi-agency meetings. This has been to support, reduce and eliminate potential risks of harm to the children.

The staff are fully aware of each child's comprehensive risk assessment strategies. These are used to reduce or eliminate the presenting behaviour that puts children at risk of harm.

Constructive and well-thought-out plans have been put in place for the children moving on to new placements. This enables children to have positive endings in their current placement.

The manager has good oversight of the home, monitoring care practice, health and safety matters and record-keeping. This helps to maintain good-quality care in line with the children's home regulations. Professionals report that there is excellent partnership working and communication to ensure that decisions are made in the best interest of the children.

Action has been taken to implement the recommendation made at the last inspection. The home has a stable and experienced staff team. Staff have undertaken mandatory training. This makes sure that continuity of care can be provided by staff who have suitable knowledge.

Staff consistently report that they are well supported by the management team and their colleagues. The pandemic has not been an easy time; however, the staff state that morale is good and that they work well as a team. This is supported by good communication systems. This includes shift handovers, regular staff meetings and formal supervision.

Most staff hold a level 3 qualification in caring for children and have undertaken the essential mandatory training along with more specialist training, for example safeguarding, county lines and child sexual exploitation. However, not all staff have undertaken training in substance and alcohol misuse. This does not give all staff the knowledge and full understanding in matters that relate to some of the children currently in their care.

At the point of a new referral for a child to be admitted to the home, the management team does undertake an impact risk assessment. This gives some consideration to the needs of children currently residing at the home along with the new referral. However, deficits have been noted. The impact risk assessment lacks detail and robust consideration of all risks pertinent to each child. Therefore, the matching of children's needs does not comprehensively record that they are all compatible to live together. Several incidents and events at the home and in the community have led to some children being put at risk of harm.

### **Statutory requirements**

This should include all areas relating to the children's needs, specifically substance misuse and alcohol awareness. ('Guide to the children's homes regulations including the quality standards', page 53, paragraph 10.11)
