Information about this children's home

This home is a short break home for seven children with learning disabilities.

The registered manager has managed this home for many years and is suitably qualified and experienced.

The home is one of four homes run by this local authority children's trust.

This monitoring visit

The purpose of this monitoring visit was to check that the provider has taken the necessary action to meet the steps set out in a compliance notice that was issued under regulation 32 on 16 April 2021.

The inspector found that the provider has taken effective steps to meet the compliance notice.

The provider has retrospectively checked recruitment files of all established members of staff and made sure that all appropriate checks have been undertaken.

The provider has also carried out a full audit of new staff appointments to ensure all checks align with regulations.

As a result, safe recruitment procedures now ensure people who work at the home are suitable to work with children.

During this visit, the inspector saw improvements in the overall appearance and cleanliness of the home. Many areas of the home have been re-painted, children's bedrooms have been refreshed with new themes and a new specialist bath has been

installed. Consequently, children have a more suitable environment in which to enjoy their short breaks.

Managers shared with the inspector how they were working with one child in creating a character (Charlie) and a package of resources which children can use on their own or with staff to express their views and raise a complaint. This means that children now have new accessible ways to express their feelings and views.

All requirements raised at the full inspection on 13 April 2021 will be reviewed at a future inspection.

Statutory requirements

In particular, the standard in paragraph (1) requires the registered person to ensure—	
that staff—	
assess whether each child is at risk of harm, taking into account information in the child's relevant plans, and, if necessary, make arrangements to reduce the risk of any harm to the child;	
understand the roles and responsibilities in relation to protecting children that are assigned to them by the registered person;	
that the premises used for the purposes of the home are designed, furnished and maintained so as to protect each child from avoidable hazards to the child's health. (Regulation 12 (1) (2)(a)(i)(v)(d))	
This specifically relates to risk assessments being updated following incidents; risk assessments having comprehensive details of the actions staff are to take to reduce risks; staff following children's plans to keep children safe; and ensuring that all areas of the home are clean and that any damage is promptly repaired.	
A responsible individual must—	30 May 2021
have the capacity, experience and skills to supervise the management of the home, or the homes, in respect of which the responsible individual is nominated. (Regulation 26 (7)(b))	
This specifically relates to the responsible individual having	



oversight of the registered manager and making sure that the registered manager is ensuring compliance with regulations.	
The registered person must ensure that all employees—	30 May 2021
undertake appropriate continuing professional development; and	
receive practice-related supervision by a person with appropriate experience. (Regulation 33 (4)(a)(b))	
This specifically relates to new staff having the skills and training needed to care for children at the home and ensuring that they receive practice-related supervision in line with the organisation's policy.	

Recommendation

■ The registered person should undertake a review that focuses on the quality of the care provided by the home, the experiences of children living there and the impact the care is having on outcomes and improvements for the children. ('Guide to the children's homes regulations including the quality standards', page 64, paragraph 15.2)
