Inspection judgements

Overall experiences and progress of children and young people: good

This is a well-maintained home. The decor provides a welcoming environment for children. There is a large garden which is home to pets, a large trampoline and play equipment. This provides an inviting space for children.

There is a calm ethos which has been promoted by the consistently good management of the home. This environment enables children to be children, despite the additional emotional challenges they may face.

This is a very settled home. Children usually stay here until they are developmentally ready to move on. Two children currently live at this home, and both have lived here for several years.

Children attend school daily and are actively engaged in their education. Outside of school, they enjoy varied activities and fun experiences.

The staff team is consistent and stable. The staff's nurturing approach is embedded firmly in their practice.

The time children spend with their peers outside of education is limited. This prevents children from enjoying healthy relationships outside of a formal setting. There is an informal plan to increase the amount of time children spend with their peers.

How well children and young people are helped and protected: good

There have been no significant safeguarding incidents. Any concerns or incidents are well managed, and a nurturing approach is consistently applied.

The boundaries set for the children are clear, and are consistently applied by the staff. This is enables children to thrive.

Any changes in the children's behaviour are fully considered and support is increased to help them when needed, for example when there are changes to the children's routines or they are struggling with difficult emotions.

Feedback from one child highlighted that they like their home and can always speak to staff when they need to.

Ongoing sexual health advice and guidance are not fully promoted. This does not ensure that children have a good understanding of this.



The effectiveness of leaders and managers: good

This is a well-managed home. The registered manager has good oversight of all areas of practice. She knows the children well and involves them in decisions about their daily lives.

The manager is invested in the children's lives and takes every opportunity to promote the best outcomes for them.

Care planning is of a good standard and children are supported to take part in the planning of their care.

Training is provided for staff to ensure that they can meet the children's needs. Some gaps in training have been identified, and there are plans to address these soon.

Recruitment is safe, and positive feedback was received from several staff regarding the care provided for children.



What does the children's home need to do to improve? Statutory requirements

Recommendation

■ The registered person is responsible for ensuring that each child's day to day health and well-being needs are met. This includes clear ongoing support regarding sexual health matters. ('Guide to the children's homes regulations including the quality standards', page 33, paragraph 7.3)
