Summary of key findings

This provision meets requirements

- The childminder has a suitable awareness of how to support children's learning and development. She understands how to differentiate activities to support all ages and stages of children and to complement the seven areas of learning.
- The childminder knows how to plan and use observations and assessments to identify and support children's next stages in development.
- The childminder understands the importance of teaching children good hygiene routines and healthy lifestyles, and the importance of setting clear boundaries to help guide their behaviour.
- The childminder acknowledges the benefits of building strong partnerships. This includes the need to share information about children's learning and development with parents, carers, and other settings that children attend.
- The childminder knows how to keep her knowledge and skills up to date. She knows how to access training and support from other professionals to evaluate and improve her own provision. The childminder has a valid qualification in paediatric first aid. This provides her with useful knowledge should she need to attend to a child who injures themselves.
- The childminder is aware of the procedures to follow to safeguard children. She knows the action to take should she ever have concerns about a child's well-being.
- The childminder has a good understanding of how to enhance babies' and children's physical and emotional well-being. She understands the importance of promoting children's self-esteem and their motivation to learn, and how this helps their move on to school.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- Discussions were held between the childminder and the inspector, to help establish the childminder's understanding of how to safeguard the children in her care.
- The inspector viewed relevant documentation, including suitability checks, evidence of paediatric first-aid training and public liability insurance.



We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
