Summary of key findings

This provision meets requirements

- The provider and staff provide a safe environment for children to play and relax in after school. They have toys and resources to suit children of various ages. The outdoor area is securely enclosed with plenty of space for physical activity.
- The provider understands the importance of working in partnership with the school and parents. She explains how the club follows the school ethos and rules to provide continuity for children. The provider and staff explain their positive strategies to manage children's behaviour.
- The provider and staff know how to protect and promote children's good health. They describe how they offer children a choice of healthy snacks and how they meet children's individual dietary requirements.
- The provider describes how she and staff reflect on their provision and will include children's ideas in their planning. They explain amendments made to usual routines and practice during the COVID-19 (coronavirus) pandemic to protect children.
- The provider and staff understand what to do if they have concerns about children's welfare. They explain how they recognise and understand that changes in children's behaviour might indicate that something is wrong. The provider and staff receive regular safeguarding training to update their knowledge. This includes wider aspects of safeguarding, including 'Prevent' duty and online safety.
- The provider understands the importance of inclusion. She describes clear arrangements to meet children's individual and additional needs. This includes working closely with parents and sharing information to benefit children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

There are three members of staff, including the owner, who work with the children. The owner and one member of staff hold appropriate childcare qualifications at level 2.

Inspection activities

- This was the first routine inspection the provider received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken that into account in their evaluation of the provider.
- During the learning walk, the provider explained their aims and organisation of the out-of-school club to the inspector.
- The inspector viewed the safety of the premises and checked required documentation, including evidence of staff's suitability.
- The inspector held discussions with the provider, staff and parents.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
