Inspected under the social care common inspection framework

Information about this children's home

This children's home is run by a registered charity. It provides care for up to eight disabled children.

The manager has been registered with Ofsted since 27 October 2010.

Inspection date: 8 June 2021

This monitoring visit

This home was judged as inadequate at the full inspection on 27 and 28 April 2021. During the inspection, evidence was found of breaches of regulations relating to safeguarding, care planning, the leadership of the home and privacy and access. Four compliance notices were issued, in relation to regulation 12, the protection of children standard, regulation 13, the leadership and management standard, regulation 14, the care planning standard, and regulation 21, privacy and access.

Ofsted carried out this monitoring visit to consider the action the provider had taken to meet the steps in the four compliance notices. There were four children living at the home at the time of the visit. Two children who visit the home for short stays were not present during the visit.

The management team has made improvements to the physical environment of the home and efforts have been made to make the living areas homelier and more comfortable. New bedroom furniture has been purchased to replace the items of broken furniture that were in some children's bedrooms. Further refurbishment work to the property is required and this is being planned in a way that will minimise disruption to children living at the home.

The registered manager has taken steps to reduce the risks arising from one child not having sufficient night-time supervision. An additional member of staff is on duty each evening and one member of staff is now based in the same part of the building

as this child. This means that the child has access to immediate help and support should they require it during the night.

Children's risk assessments have been reviewed and are aligned to the child's needs and any known risks the child may be vulnerable to.

The home's fire risk assessment has been reviewed and the manager has taken swift action to address and resolve the risks identified in the risk assessment. The manager has also conducted an additional risk assessment of the safety of the sleeping arrangements of one child. As a result, additional measures are now in place to support the safe evacuation of this child in the event of a fire.

The home's fire evacuation procedures have been updated to reflect the practice in the home. Staff spoken with during the monitoring visit demonstrated a good understanding of these procedures and the actions they would take to safeguard children.

The manager has taken steps to ensure that where there are restrictions of liberty for children, these restrictions are kept under review. The staff team is being provided with additional training regarding restrictive practices and the law. This has helped to increase their understanding in this area.

The manager has ensured that there are sufficient staff available to meet the assessed needs of all the children living at the home. Agency staff are being used to cover gaps in the staff roster. However, the manager has taken action to recruit more staff. In the interim, she has taken steps to try and ensure that only agency staff who are familiar to the children are used. This provides children with more continuity of care.

The registered provider has not yet taken sufficient action to review the range of needs and compatibility of children living at the home or to resolve the issues arising from their incompatibility. For example, children are not well matched and one child can become distressed by noises made by other children who live in the home.

In addition, the compliance notice issued in relation to regulation 14 required the registered provider to develop effective impact risk assessments to support their decision-making in relation to admitting new children to the home. The registered provider has not completed this action within the required timeframe. Therefore, a compliance notice in relation to regulation 14 is issued again because the registered provider has not yet fully completed all the steps outlined in the original compliance notice.

The compliance notices issued under regulations 12, 13 and 21 have been met. Additional requirements made at the full inspection were not considered during the monitoring visit, so are repeated for consideration at the next routine inspection.

Ofsted will continue to monitor the provider closely to ensure that improvements are sustained.

Statutory requirements

Requirement	Due date
*The care planning standard is that children—	1 August 2021
receive effectively planned care in or through the children's home.	
In particular, the standard in paragraph (1) requires the registered person to ensure—	
that children are admitted to the home only if their needs are within the range of needs of children for whom it is intended that the home is to provide care and accommodation, as set out in the home's statement of purpose. (Regulation 14 (1)(a) (2)(a))	
The registered person must make arrangements for the handling, recording, safekeeping, safe administration and disposal of medicines received into the children's home.	6 June 2021
In particular the registered person must ensure that—	
medicine which is prescribed for a child is administered as prescribed to the child for whom it is prescribed and to no other child. (Regulation 23 (1) (2)(b))	
After consultation with the fire and rescue authority, the registered person must—	6 June 2021
provide adequate means of escape from the home in the event of a fire;	
ensure, by means of fire drills and practices at suitable intervals, that persons working at the home and, so far as is reasonably practicable, children are aware of the procedure to be followed in the case of a fire. (Regulation 25 (1)(b)(d))	



The registered person must ensure that an independent person visits the children's home at least once each month.

When the independent person is carrying out a visit, the registered person must help the independent person—

to inspect the premises of the home and such of the home's records (except for a child's case records, unless the child and the child's placing authority consent) as the independent person requires.
