Summary of key findings

This provision does not meet requirements

- The childminder does not reflect on her practice regularly enough to identify all breaches to requirements. She does not have an appropriate first-aid qualification as required. This was an action set at the last inspection.
- The childminder lacks knowledge of safeguarding procedures and how to report concerns about a child's welfare locally. She is unaware of safeguarding issues, such as when a child may be at risk of female genital mutilation and how to report allegations. The childminder has poor knowledge of the 'Prevent' duty guidance. She knows how to identify and minimise the hazards to keep children safe in her home.
- The childminder does not have appropriate resources to support children's learning and development. She is unsure how to plan for children's learning to support them to make the best possible progress and prepare them for the next stage in learning. The childminder is unaware of how to complete the required assessments, such as the progress check for children aged between two and three years.
- The childminder knows how to support children's understanding of positive behaviour, accepting of each other's differences, and valuing diversity. She understands how to encourage children to lead healthy lifestyles, for instance, through physical play outdoors and promoting healthy eating habits.
- The childminder understands the benefit of working in partnership with parents and others involved in children's development, to help provide continuity in children's care and learning.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

- This was the first inspection the childminder received since the COVID-19 (coronavirus) pandemic began. The inspector discussed the impact of the pandemic with the childminder and has taken that into account in their evaluation of the setting.
- The inspector had discussions with the childminder about her understanding of how to safeguard children and to promote their learning.
- The inspector looked at a range of relevant documentation and discussed this with the childminder.
- The inspector viewed all areas available for childminding.
- The inspector checked evidence of the suitability of the childminder to work with children.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
