Summary of key findings

This provision meets requirements

- The well-qualified and experienced manager has an in-depth understanding of how to provide an appealing range of activities for children during the school holidays. The programme of activities is centred on providing a varied range of arts and crafts and sports activities for children.
- The manager places a clear focus on valuing the uniqueness of each child and ensures all staff can confidently tackle any negative stereotypes. Staff are trained to support all children to benefit from the programme of activities provided.
- The manager understands the importance of collating detailed information about children's medical and personal needs. She uses effective systems to ensure all the required information about children's care and health needs is obtained prior to a child starting at the club.
- The manager recognises the value of obtaining the views of parents, children and staff to help her evaluate what they provide and further develop the service on offer. Parents are consulted regularly during their child's time at the club.
- The manager ensures all the required safeguarding policies and procedures are in place to help ensure the safe and effective management of the club. She has a secure understanding of child protection issues and the procedures to follow. All staff receive a detailed induction and up-to-date safeguarding training. The premises are safe and suitable and detailed risk assessments are undertaken of any activities taken outdoors to ensure children are safe.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- This is the first inspection the club received since the COVID-19 (coronavirus) pandemic began. The inspector discussed the impact of the pandemic with the registered individual and has taken that into account in her evaluation of the club.
- The registered individual, who is also the manager, and the inspector completed a learning walk together to check the safety of the premises and to gather information about the experiences provided.
- The inspector held a meeting with the manager and staff. She looked at relevant documentation and evidence of the suitability of staff working at the club.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
