Summary of key findings

This provision does not meet requirements

- The childminder does not have sufficient knowledge of what to notify Ofsted about. She has failed to inform Ofsted about changes of her home address in a timely manner.
- The childminder does not support her professional development to ensure she has up-to-date knowledge. She is not aware of all safeguarding issues, particularly of the 'Prevent' duty guidance. However, the childminder has some awareness of the procedures for reporting concerns to relevant agencies.
- The childminder knows how to monitor and track the progress of children to help them make progress. She has suitable toys and resources that children can access readily.
- The childminder is aware of the importance of working in partnership with parents. She aims to share information with them to help manage children's behaviour.
- The childminder does not evaluate her practice to identify breaches of the requirements.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

Inspection activities

- This was the first routine inspection the setting received since the COVID-19 (coronavirus) pandemic began. The inspector discussed the impact of the pandemic with the childminder and has taken that into account in her evaluation of the setting.
- The childminder showed the inspector all areas of her home and explained how she intends to risk assess the setting.
- The inspector sampled the childminder's documentation, including her training certificates. She looked at the available equipment and toys for the use of young children.
- The childminder explained to the inspector how she intends to implement the early years curriculum. She also told the inspector how she plans to work with parents.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
