Due to COVID-19 (coronavirus), at the request of the Secretary of State, we suspended all routine inspections of social care providers on 17 March 2020.

This monitoring visit

The purpose of this monitoring visit was to assess the suitability of the home to start operating again following a period of temporary closure.

This home was initially registered in 2016, the provider paused becoming fully operational. This was following a difficult period within the wider organisation. Staff and managers were redeployed. In addition, a significant number of staff left the organisation.

The new senior leadership team has now decided to reopen the home and begin to admit children. A new manager has been appointed. He has sufficient experience and is working towards completing the appropriate management qualification.

A new staff team has been appointed. The staff are undertaking a range of training to give them the knowledge and skills to care for children. Additionally, they are gaining experience by working in other homes within the organisation. The training, combined with experience in other settings, will prepare staff to care for children in this home.

The home's policies and procedures are suitable and up to date. The statement of purpose for the home provides clear information about its aims and objectives. This

means stakeholders will be able to understand what the home aims to achieve for children. The location risk assessment has also been updated by the manager. This is a good and informative document.

The home is furnished and decorated to a high standard and will provide children with a home they can be proud of. The home is now ready and able to admit children.
