Summary of key findings

This provision meets requirements

- The childminder describes how she will observe children and assess their development to plan for what they need to learn next. She understands how she can support children of different age groups. The childminder discusses how she will plan activities that motivate and interest children across all areas of learning.
- Through discussion, the childminder shares how she will keep children safe and protect them from harm. She describes what she will do if she has a concern about the welfare of a child. The childminder talks about how she accesses relevant training to keep her knowledge of child protection up to date. She holds a valid first-aid certificate and talks confidently about how she will deal with accidents and incidents appropriately.
- The childminder recognises the need to work in partnership with parents and other settings that children attend to help support children's individual needs. She describes how she will share information about children's progress, to complement their learning.
- The childminder describes how she will promote children's health. She knows the importance of teaching children the importance of good hygiene and following a healthy diet. The childminder talks about how she will involve children in planning menus and will cater for children's individual dietary needs. She discusses how she will encourage children to harvest, cook and eat fruit and vegetables that they have planted on her allotment.
- The childminder talks about how she will provide regular opportunities for children to be physical in the fresh air. She is a trained forest school leader and shares how she will provide children with activities to explore and to investigate each day outdoors. The childminder describes how she will take children on a variety of outings in the local environment, to help them develop an awareness of the world around them.
- Through discussion, the childminder shows an understanding of how to manage children's behaviour. She discusses how she will use praise to raise children's self-esteem. The childminder describes how she will teach children to become independent and prepare them well for school.
- The childminder is committed to enhancing the quality of her provision. She shows an understanding of the importance of extending her skills and knowledge. The childminder has recently attended training to make sure that her knowledge is up to date, for example, around recent changes to the early years foundation stage. She has also completed recent training to support children's mental health and well-being, following the COVID-19 (coronavirus) pandemic.
- The childminder talks confidently about her experience in working with children with special educational needs and/or disabilities. She aims to offer a welcoming and inclusive setting. The childminder describes how she will work with other professionals, such as health visitors and speech and language therapists, to help all children make the best possible progress.



There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector looked at a sample of the childminder's documentation that she intends to use when caring for children.

The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
