

## Lavender Field School

**Overall outcome** 

The school is likely to meet the relevant independent school standards if the material change relating to the school provision is implemented

### Main inspection findings

Part 3. Welfare, health and safety of pupils

Paragraph 7, 7(a), 7(b), 32(1)(c)

- The school's detailed safeguarding policy is compliant. The policy is available from the school's website. It is based on procedures that are already used effectively in the school. Appropriate systems are in place for recording any safeguarding concerns. These procedures will be suitable if the request for an increase in pupil numbers is granted.
- The safeguarding team in the school has experience of developing effective welfare provision. Staff receive a wide range of training linked to safeguarding and welfare. Additionally, they are suitably trained in the behaviour management of pupils. This ensures that they understand how to keep pupils safe. Leaders plan to follow the established induction procedures already in place to recruit new staff.

#### Paragraph 11, 12, 14, 16

- The school is likely to be compliant with the Regulatory Reform (Fire Safety) Order 2005. Leaders ensure that regular fire audits and fire-risk assessments are carried out. Any issues that are identified are remedied quickly. For example, the plan of the fire escape route and fire exit signage have been revised and are clearly displayed near the proposed new classrooms.
- Leaders intend to have high staff-to-pupil ratios. Leaders intend numbers of pupils to grow gradually. Staffing levels will then increase accordingly. The planned staff numbers would be appropriate to ensure suitable supervision of pupils if the request for an increase in pupil numbers is granted.
- There is a written health and safety policy in place. This complies with relevant legislation. Leaders have created systems to record health and safety checks. These will be routinely evaluated by leaders.
- The written risk assessment policy clearly outlines the responsibilities of staff and leaders. The detailed risk assessments explain the measures to take to identify and



minimise potential risks to pupils' welfare. This includes the new classrooms and other areas of the school that it is proposed are used for the increased number of pupils.

■ The proprietor body has ensured that all the independent school standards (the standards) in this part are likely to be met.

- The appointment of staff is carried out in accordance with statutory guidance. The single central record is already in place, and includes 'critical friends', proprietors and staff. It contains all the required information, including whether any adults are subject to prohibition orders.
- The proprietor body has ensured that all the standards in this part are likely to be met.

#### Part 5. Premises of and accommodation at schools

- There is a suitable amount of classroom space for the intended number of pupils. There are four new classrooms alongside existing classrooms. The new area, located within the existing building, includes an office for staff and retreat rooms for pupils to use.
- The classrooms are well ventilated and both lighting and acoustics are suitable. Classrooms are appropriate for the requirements of the intended curriculum. Leaders have paid attention to pupils' welfare and safety within the new area to be used. The new classrooms have been finished to a high standard.
- Drinking water is clearly labelled and is available throughout the building and near the new classrooms. Washing facilities are also available close to the learning areas. The temperature of the hot water does not pose a scalding risk.
- There are sufficient toilets and showering facilities close to the proposed new classrooms. These are suitable for the proposed increase in numbers.
- There is sufficient outside space for pupils to play safely at breaktimes. It is also large enough for pupils to take part in physical education (PE). The use of two playgrounds and the rota system in operation mean that this is suitable for the proposed number of pupils. There is a park opposite the school, and local sports centres that are used

- for PE. Leaders have appropriate risk assessments in place to ensure the safety of pupils travelling to and from the centres, and while they are inside the centres.
- The proprietor body has ensured that all the standards in this part are likely to be met.

- Leaders are experienced in managing similar types of school. They have significant educational experience and a successful track record in providing education for pupils with special educational needs and/or disabilities (SEND). Leaders have a strong understanding of the standards and other requirements of the Department for Education (DfE) when running a school, as they have already fulfilled them successfully at this and other schools.
- Leaders have the necessary skills and knowledge to ensure that established policies provide for the safety and welfare of pupils, including the proposed increase in numbers.
- The proprietor body has ensured that all the standards in this part are likely to be met.

■ The school has in place an appropriate accessibility plan. Leaders have ensured that the requirements under Schedule 10 of the Equality Act 2010 are likely to be met.

#### Information about this school

- The school caters for up to 50 mixed-gender pupils aged five to 19 years. The school is an independent special school that caters for pupils with SEND, of which some will be children looked after by the local authority.
- The school provides for pupils with complex social, emotional and mental health needs, autism spectrum disorder and/or cognitive and learning difficulties. All pupils have an education, health and care plan.
- The directors are also directors of three other registered independent schools.
- The school does not use any alternative provision.



## Information about this inspection

- This inspection was commissioned by the DfE to evaluate the school's application for a material change. The proprietor wishes to increase the maximum number of pupils on roll from 50 to 100.
- This was the school's first material change inspection. The first standard inspection of the school took place on 29 June to 1 July 2021. The school was registered by the DfE on 28 July 2020.
- The inspector held discussions with the executive headteachers, the deputy headteacher, the school business manager and a member of the proprietor body.
- The inspector toured the school premises and visited the proposed new classrooms. He reviewed the school's website and considered a range of school policies and procedures.
