Inspected under the social care common inspection framework

Information about this children's home

The home is privately run. It provides care for up to nine children with learning disabilities.

There is no registered manager in post.

Inspection date: 12 August 2021

This monitoring visit

This home was judged inadequate at a full inspection on 16 and 17 June 2021. The inspector identified serious and widespread poor practice at the home.

The purpose of this visit was to assess the progress made by the provider regarding compliance notices issued under section 22a of the Care Standards Act 2000. These related to regulation 8 (the education standard), regulation 12 (the protection of children standard), regulation 13 (the leadership and management standard) and regulation 14 (the care planning standard).

Education plans are now in place for children. Plans show the actions that the staff take to promote children's informal learning and to help them to meet their individual targets. A child's transition plan demonstrates how the staff will help a child to prepare for starting school in September. A key person has applied for a college course for another child. The staff are more proactive in encouraging children's interests, to help them to overcome barriers to learning.

One child's personal education plan (PEP) is now on file. The responsible individual has escalated the request for another child's PEP at a meeting with the placing authority. The provider has requested that an education, health and care plan is expedited to ensure that the child's needs will be met going forward.

The staff have reviewed the children's risk management plans. They have addressed how they help children to understand what needs to happen in the event of a fire,

for example by using pictures. They are more proactive in trying to help children to understand how to keep themselves safe.

The staff have had additional training and now understand and demonstrate the actions they need to take to keep children safe. There are better systems in place to monitor the staff team's knowledge and response. Some plans are not updated to guide practice regarding some re-emerging risks, but staff are aware of the concerns and know what they need to do.

The home environment is much improved. The work is being carried out with sensitivity to the children's needs so that they do not become upset or face disruption to their routines.

Recruitment for a new manager is ongoing. An assistant manager is now in post. She has developed assurance systems to ensure that the staff develop plans that reflect children's individual needs and track their progress. New senior team members provide support and guidance to the whole staff team. This means that there is greater consistency in how the team works to support children in line with the statement of purpose. Staff report feeling more positive and confident in their roles.

Team members have been enrolled to achieve a suitable residential childcare qualification. The staff say that recent additional training helps them to better understand children's individual needs. This means that they respond differently, for example when a child gets upset and frustrated. As a result, there are fewer incidents.

New documentation is in place to ensure that all children's needs are assessed so that they can safely live at the home together. No new children have moved to the home to test its effectiveness. However, the responsible individual will have oversight of all future referrals and pre-admission planning when a new manager is recruited.

Children's family members are now visiting the home. An additional telephone has been bought to ensure that there are no barriers to children speaking to their families. Clear plans are in place about arrangements for family telephone and video calls as well as visits.

There are several review systems now in place with clear lines of accountability. Specific meetings are held regularly with key members from across the organisation to review children's plans. This ensures that children's plans are updated promptly to provide practice guidance for the staff and to track children's progress and experiences more effectively.

The provider has demonstrated adequate progress to meet the steps of the compliance notices. A case review was held on 16 August 2020. The decision was taken to address the shortfall under regulation 12 by setting a requirement.

Recommendations

- The registered person should ensure that the review of the location of the home considers specific risks for individual children, such as railway stations, and how the staff should respond to mitigate them if a child leaves the building. ('Guide to the children's homes regulations including the quality standards', page 64, paragraph 15.1)
- The registered person should ensure that the staff record information about individual children in a non-stigmatising way that is helpful to the child if they choose to read their records at a later date. ('Guide to the children's homes regulations including the quality standards', page 62, paragraph 14.4)
- The registered person should ensure that the workforce plan contains the details of the staff team's current qualifications and identifies any further training required. ('Guide to the children's homes regulations including the quality standards', page 53, paragraph 10.8)
