Summary of key findings

This provision does not meet requirements

- The provider does not ensure that at least one person with a full paediatric firstaid qualification is present when children are being cared for. Staff do not complete the training required to help them understand how to respond in a medical emergency. This does not ensure children's welfare.
- The manager has a secure understanding of safeguarding procedures, including how to respond if concerned about the behaviour or actions of a staff member. Staff update their safeguarding knowledge and demonstrate that they understand how to implement school collection procedures.
- The manager demonstrates that she works in partnership with school staff to ensure accurate records of children's accidents are maintained. She recognises the importance of working closely with parents and others so that children's needs are met, including those who have additional health or learning needs.
- The manager describes how she plans enjoyable and inclusive activities that interest and engage children. She explains how staff gather information from children and school staff in order to build on what children enjoy and understand. The manager describes how staff provide resources that help children to follow instructions, behave well and build positive relationships with their friends.
- The manager understands how to support children to develop healthy lifestyles and keep themselves safe. For example, children are given frequent opportunities to play outdoors and are offered nutritious meals that meet their dietary requirements.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

It operates from 7am to 9am and 3.15pm to 6pm each weekday during term time. Four staff work directly with the children. Of these, two staff, including the manager, hold relevant qualifications at level 3 or above.

- The inspector looked at documents. These included evidence of the suitability of staff, policies and evidence of the professional development of staff.
- The inspector discussed children's activities and safeguarding with the manager.
