What is it like to attend this early years setting?

This provision does not meet requirements

Children's safety and well-being are undermined by breaches of requirements identified during this inspection. In addition, the provider has failed to address some of breaches of requirements she acknowledged at a prior visit. Some children, particularly younger ones, do not have resources and activities that are tailored to their interests. The provider does not find out relevant information about their likes and dislikes when they first start. While staff are kind to children, they do not know enough about some children to meet their needs.

Older children, particularly those who have been at the club for a while, know where to find toys that they want. Older children are generally well occupied and have opportunities to develop physical and social skills. For example, as they organise a game of football, they enjoy exercise in the fresh air and learn to cooperate with each other. Other children kick their feet in leaves and catch balls in cups. Children behave well and are kind to one another. Children make selections from their lunchboxes, choosing a snack independently. Staff help them to fetch their water bottles, helping them to manage their own health needs.

What does the early years setting do well and what does it need to do better?

- The provider, who is also the manager, has taken some action to meet notices that were served following a previous visit to the club. For example, she has ensured that there is least one person present with a full paediatric first-aid qualification at all times when the club is in operation. She has attended training to improve her own knowledge of the appropriate methods for managing children's behaviour.
- The provider has failed to meet other notices served following the previous visit. She has not ensured that the designated person for safeguarding can understand and implement procedures to recognise, respond to and refer potential concerns about children. Additionally, she has not gathered relevant information about children, especially when they first start, to meet their needs and to help staff engage with them.
- The provider has not appointed a named deputy manager who is capable to take charge in her absence. When the provider is not present, there is no person to ensure that staff have the knowledge and skills they need to meet children's needs, or to plan interesting things for them to do. The provider has not allocated all children in the early years age range a key person. This means that there are poor settling arrangements for some younger children who are new to the club. While they find something to do from the toy cupboard, staff to not interact with them to make sure they feel secure and welcomed.
- The provider has not made sure that staff have access to specific medication



that children may need to ensure their good health. She has not sought permission from parents to administer such medication. This means that staff may be unable to respond to children's needs quickly to ensure their safety.

- Children play cooperatively and enjoy playing games outside in the fresh air. Minor disagreements are managed well by staff, who remind children what is expected of them. Older children play together happily. However, younger children do not have sufficient engagement from staff to help them to develop their social skills, or to fully explore toys and games at the club.
- Parents report that their children like coming to club and are happy here. Parents appreciate the flexibility the opening times of the after-school-club provide and state that their children form warm attachments to particular members of staff.
- Areas and equipment used by children are safe and suitable to meet their needs. For example, children play with well-maintained toys and equipment. There is a secure entry system and a well-enclosed outdoor area, and staff supervise children as they play.

Safeguarding

The arrangements for safeguarding are not effective.

The designated person for safeguarding does not have sufficient knowledge and understanding of child protection matters to ensure that all staff can recognise and respond to signs of concern about children in a timely manner. Staff have not been trained to understand local procedures for child protection or how to contact relevant agencies with any concerns. The provider has failed to meet a previous notice served requiring them to improve the knowledge of the designated person for safeguarding.

What does the setting need to do to improve?

The provision is not meeting requirements and Ofsted intends to take enforcement action.
